Dear Ms. Hennessey:

Due to sudden, dramatic and unexpected business circumstances and economic conditions, the management of Lapeer Metal Stamping Companies, Inc. has determined to eliminate permanently the majority of its welding operations and eliminate various nonbargaining unit positions at its facilities located at 930 S. Saginaw, Lapeer, MI 48446 and 1070 Clark Street, Lapeer, MI 48446. As a result, approximately 83 employees overall will be permanently separated from employment. It is our understanding this may well constitute a plant closing or mass layoff under the Worker Adjustment and Retraining Notification Act ("WARN"). Less than 60 days notice of such layoffs may be provided due to the sudden, dramatic and unexpected business circumstances and economic conditions the Company is experiencing, i.e., unexpected reduction in customer orders.

We anticipate that initial permanent layoffs will commence on or about January 1, 2008 and continue through on or about January 14, 2008. Attached is a list of the job titles of positions and the names of the workers currently holding affected jobs.

Bumping rights may exist for the facilities' bargaining unit personnel between Lapeer Metal Stamping Company's facilities at 930 S. Saginaw and 1070 Clark Street. Additionally, transfers to positions at the Company's facilities located at 8111 Tireman, Dearborn, MI 48126 and 249 Center Road, Sebawaing, Michigan 48759, may be available.

Some of the employees are represented by UAW, Local 9699. The local union's president is Robert Burluson whose address is UAW Local 9699, 6038 East Marlette Road, Marlette, MI 48453-0355. The international representative of the UAW servicing our Lapeer facilities is Mike Stone, UAW, Region 1, 27800 George Morelli Dr., Warren, MI 48092.
