INTENDED MEETING OUTCOME

This meeting was conducted for the following purposes:

- Strategic Prevention Enhancement (SPE) Project Status.

SUMMARY OF KEY POINTS

Introductions and Welcome: No introductions were needed; however, it was learned that Lauren Kazee, Gery Shelafoe, Jill Worden, and Mary Ludtke were on the phone.

Approval of Agenda: Approved by consensus.

Approval of Meeting Minutes: Minutes from May 17, 2012, were approved by consensus

BSAAS Updates:

- **General** – The meeting with members of Michigan collaborative coordinators went well. Collaboratives are cooperating with coordinating agencies (CAs) and are interested in suicide prevention prepared communities. The PowerPoint presentation worked. They were interested in hearing about strategic planning framework and SPE projects. Mary commended Larry and Marie for taking questions through their lunches. Mary will send Larry information on the suicide collaboratives around the state. A recap of the meeting will be sent out to the members of the SPE workgroup.
- **Trainings coming up** – Screening, Brief Intervention, and Referral to Treatment (SBIRT) Training of Trainers (ToT) – four slots are dedicated to CAs receiving the SBIRT grant from BSAAS to send someone to the trainings. A couple slots are going to coalitions, and one to Michigan Department of Education (MDE). Larry mentioned that the training is very intense but participants will have an opportunity to review information beforehand. The purpose is to disseminate the information to partners and stakeholders.
- **Suicide prevention training** – Patti Smith from MDCH Mental Health agreed to conduct the training. Central Collaborative for the Application of Prevention Technologies (C-CAPT) meeting: they will provide training and are putting together a series of workshops that will occur later in the summer and in next fiscal year. There will also be more training on trauma-informed systems. Dr. Steve Guertin at Sparrow Hospital will do a workshop at the Substance Use Disorder (SUD) conference and will be speaking about his personal experience treating underage overdoses related to alcohol in the emergency room. As far as SPE funding is concerned, there is an opportunity for a no cost extension year. Marie submitted the SPE nine-month report. Liz has agreed to meet with ROSC TSC committee. Mary mentioned that they were planning a suicide prevention conference October 14-16 in Roscommon County.

SPE Project Status:

- The original scans are on their way to the web. Submission for approval of the scan that will go to mental health is almost ready. Liz mentioned that it was nearly finalized and ready to send out to community mental health service providers (CMHSPs) and prepaid inpatient health plans (PIHPs) in the five regions. Liz mentioned that the cover letter should be tweaked to explain the most recent scan.

Five-Year Plan:

- There is one more meeting before the five-year plan is due, and then will be submitted.
- Questions were asked, “How much do we want to envision this project as working over the next five years in the five regions that had high need? Should we see what happens if we focus in those groups for three to four years until we begin to see a change in the outcome data?”
- Marie asked, “Are we talking about having prevention prepared communities (PPCs) in every community by the end of two years or five years?”
- Achilles said we need to stop and reflect based on experience in the five communities as to what worked and what didn’t work. We already know some things that did work and others that we could do better. The environmental scan gave lots of information, seems to be a natural fit to the process. Other thing is the language of the PPC; when presenting, show it as a bridge between the SPF and SPE, rather than a new concept.
- Marie asked if the scans vary between the five regions. Liz said she would break it down to big areas and low areas and come up with a shorter version of the scan, the core items. She doesn’t think a workforce scan needs to be done. The Center for Substance Abuse Treatment (CSAT) will be doing a workforce scan.
- Jim mentioned the scalability of information.
- Liz suggested we create a trend of data and use that to develop the scans; we can then ask what the emerging issues are. Liz thinks broad categories should be: Assessment – could be a brief environmental scan, Tasks – would be inventory that was performed, Education, Work – that was performed around PPC, and Next Steps – for developing PPC collaboration across systems. Perhaps need Liz to draw out her vision of what the plan or model should look like, i.e.: assessment, ongoing educations, and cross trainings.
- Marie said it seemed that suicide prevention may be one of the best goals that will help collaborate across the mental health, prevention, and primary care systems, and bring everyone to the table; right now we are not seeing people talking to each other. Rather than creating a new group, we can connect with the suicide coalitions in counties that have organized efforts. There is an UP-wide suicide group though not many people are aware of it. Jill will look into getting an updated list. Marie said that one of the goals is to get everyone within a community connected with each other.
- Marie also noted the need for a piece about underage drinking and adult binge/problem drinking. Do the five communities see themselves any further along in their planning around the underage drinking (UAD)?
- Achilles is not convinced that the five regions are necessarily ahead of the rest of the regions so suggests scanning.
- Larry said we need to send some kind of scan to 11 additional CAs to determine where everyone is at. Need a follow up scan to find out what happened after the workshops and trainings. Another thing – what are we doing with primary care? It should be set up with SPF/SIG methodology.
- Brenda said the first quarter of the five-year plan could be assessment.
- Marie asked, “How well can we connect through efforts of SBIRT?”
- Liz said there has to be one thing that the five would agree to work on similarly.
- Gery asked, “Once SBIRT is pushed, will it have made a difference?”
- Joel mentioned that there are limitations but the trainings and knowledge base is positive.
- Larry said they have not been integrating prevention of SUD with mental health issues. How do we merge prevention with mental health issues? This is another thing that the strategic plan can address.
- Marie reiterated that what she heard was that we wouldn’t be ready to roll this out in the first year, but also what is clear is that it isn’t just the five CAs that we have selected that are moving along on this.

NEXT STEPS

- Need feedback from 11 CAs – Liz can send out a quick Zoomerang that CAs can send out to coalitions.
- Next meeting date –July 10th at 2:00 – 4:00 was presented as an option. Lori will send out notice.
