Vaccines for Children (VFC) Program

The VFC program provides publicly purchased vaccines to VFC-eligible children through public and private providers.

The VFC Program:

- Automatically covers vaccines recommended by the Advisory

Michigan Care Improvement Registry (MCIR)

Reduction of vaccine-preventable diseases through immunization is a top priority for the Michigan Department of Health and Human Services (MDHHS). Many people in Michigan receive immunizations from multiple providers. Without access to accurate patient immunization records, providers find it

The Assessment, Feedback, Incentives, & eXchange (AFIX) Quality Improvement Program

AFIX is a proven method to increase vaccine coverage levels. The **Classic AFIX** is available free of charge and focuses on the processes and behaviors associated with immunizing patients at the practice.

Classic AFIX sessions include:

- 1-hour meeting with the physician and staff
- Immunization data specific to the practice
- Focus on efforts to improve vaccinations
- Pediatric and Adolescent vaccinations

- Quality improvement plan with recommendations
- Assists with existing immunization quality improvement strategies
- Can provide improvements in data used for Health Employer Data and Information Set (HEDIS) measurements
