

# ESTIMATES OF YEAR-END GENERAL FUND/GENERAL PURPOSE APPROPRIATION LAPSES

(FY2010 Appropriation Bill - Public Act 131 of 2009)

December 1, 2010

**Section 287:** Not later than December 1, 2010, the department shall prepare and transmit a report that provides for estimates of the total general fund/general purpose appropriation lapses at the close of the fiscal year. This report shall summarize the projected year-end general fund/general purpose appropriation lapses by major departmental program or program areas. The report shall be transmitted to the office of the state budget, the chairpersons of the senate and house appropriations committees, and the fiscal agencies.
