Providers are being notified of HCPCS code changes that will be implemented by the Michigan Department of Community Health (MDCH). This notice is distributed to a broad range of providers and not all codes listed will apply to your scope of practice and/or beneficiary program coverage. The coding information is based on the most recent July 2011 file from the Centers for Medicare & Medicaid Services (CMS) and the HCPCS code book. Refer to the CMS website (www.cms.hhs.gov) and the HCPCS code book for full descriptions of the codes.
