Subject: Rate Increase for Obstetrical Services

Effective: October 1, 2014

Programs Affected: Medicaid, Healthy Michigan Plan, Maternity Outpatient Medical Services (MOMS)

This bulletin is being issued in response to the Michigan Department of Community Health's (MDCH) Fiscal Year (FY) 2015 budget contained in Public Act 252 of 2014.

Section 1862 of the Act directs MDCH to increase Medicaid reimbursement rates for obstetrical services to 95% of Medicare rates. Effective for dates of service on and after October 1, 2014, the rate increase will be implemented for the following obstetrical services:
