Subject: Occupational Therapist (OT) and Occupational Therapist Assistant (OTA) Licensure

Effective: As Indicated

Programs Affected: School Based Services Fee-for-Service and Administrative Outreach Programs

The purpose of this bulletin is to inform providers of policy updates to comply with Public Act 523 of 2008 which requires OTs and OTAs to be licensed by the State of Michigan.

This Public Act amended part 183 of the Public Health Code (Occupational Therapists) to provide for the licensure of OTs and OTAs rather than the previously required registration of a certified OT or OTA.

Licensure Requirements for OTs and OTAs

Public Act 523 defines an OT as "an individual licensed under this article to engage in the practice of occupational therapy," and an OTA as "an individual licensed under this article to engage in practice as an occupational therapy assistant."

Occupational therapy services are those services provided to promote health and wellness, prevent disability, preserve functional capabilities, prevent barriers and enable or improve performance in everyday activities.

The Bureau of Health Professions, Health Systems and Health Profession Licensing issued a letter that as of January 13, 2009, licensure is required for both OTs and OTAs instead of current registration. The new law also requires continuing education requirements for licenses.
