Resolution by Michigan Civil Rights Commission to conduct hearings regarding alleged issues of discrimination in the Educational System in Michigan Whereas.

Article 5, Section 29 of the Michigan Constitution establishes a civil rights commission whose duty is in a manner prescribed by law to investigate alleged discrimination against any person because of religion, race, color or national origin in the enjoyment of civil rights guaranteed by law and by the constitution, and to secure the equal protection of such civil rights without such discrimination.

Whereas.

Act 453 of 1975, known as the Elliott-Larsen Civil Rights Act and related Acts, prohibits discriminatory practices, policies and customs in the exercise of those rights based upon religion, race, color, national origin, age, sex, height, weight, familial status, disability or marital status;

Whereas.

Article 5, Section 29 of the Michigan Constitution, empowers the commission to hold hearings, administer oaths, through court authorization require the attendance of witnesses and the submission of records, to take testimony, and to issue appropriate orders:

Whereas.

Article 6(2) of the Elliott-Larsen Civil Rights Act stipulate that the commission may hold hearings, administer oaths, issue preliminary notices of witnesses to appear, compel through court authorization the attendance of witnesses and the production for examination of books, papers, or other records relating to matters before the commission, take testimony of a person under oath, and issue appropriate orders; AND

Whereas,

Based on the opinion of multiple experts across the State of Michigan who unanimously assert that Michigan's education system is in crisis. And based on reports that show that minority and special needs students are the most vulnerable based on inequities as documented in the MCRC Flint Water Crisis Report published in February 2017. THEREFORE,

The Michigan Civil Rights Commission shall utilize the powers granted to it by the Michigan Constitution, the Elliott-Larsen Civil Rights Act and related Acts to convene a series of at least three (3) public hearings to accept and/or compel testimony to address the question of whether the Civil Rights of underserved students in Michigan have been violated or abridged.

Subject to the approval by a majority of its members present at a properly convened meeting, the commission also directs the Michigan Department of Civil Rights to allocate the resources necessary to enable the commission to convene the first of a series of public hearings to be held on or before May 31, 2018.

RECONSIDERATION OF EQMI REQUEST FOR INTERPRETIVE STATEMENT

**Commissioner Smith offered the following Motion:** 

I MOVE THAT THE MICHIGAN CIVIL RIGHTS COMMISSION ADOPT THE FOLLOWING RESOLUTION AS INTERPRETIVE STATEMENT 2018-1 REGARDING THE MEANING OF "SEX" IN THE ELLIOTT LARSEN CIVIL RIGHTS ACT (ACT 453 OF 1976) AND GIVE IT IMMEDIATE EFFECT.

WHEREAS, the Michigan Civil Rights Commission finds the language "discrimination because of... sex..." as used in the Elliott Larsen Civil Rights Act ambiguous, leaving the MI Department of Civil Rights without clear authority to accept complaints of discrimination based on "gender identity" and "sexual orientation", the Commission issues Interpretive Statement 2018-1.

WHEREAS, the Michigan Civil Rights Commission finds that the definition of "discrimination because of... sex" under Michigan law has to date been interpreted to be less inclusive than the definitions of other protected classes, and in a way that is contrary to the plain meaning of the language in this context.

WHEREAS, The Michigan Civil Rights Commission finds that both discrimination because of gender identity and discrimination because of sexual orientation are forms of discrimination because of sex.

WHEREAS, the U.S. 6th Circuit Court of Appeals on March 7, 2018 ruled in the case of EEOC v R.G. & G.R. Harris Funeral Homes Inc. that the same language "discrimination because of ... sex" when used in federal civil rights law protected a transgender Michigan woman who was gender stereotyped and discriminated against for not behaving like a male, and adding Michigan where gender identity and sexual orientation are already federally protected under the definition of "discrimination because of sex."

WHEREAS, The Michigan Civil Rights Commission finds that continuing to interpret the protections afforded by the phrase "discrimination because of... sex" more restrictively by continuing to exclude individuals for reasons of their gender identity or sexual orientation, would itself be discriminatory.

WHEREAS the Michigan Constitution of 1963 provides that "no person shall be denied the equal protection of the laws" and directs that "It shall be the duty of the commission in a manner which may be prescribed by law to investigate alleged discrimination against any person... and to secure the equal protection of such <u>civil</u> rights without such discrimination... The commission shall have power, in accordance with the provisions of this constitution and of general laws governing administrative agencies, to promulgate rules and regulations for its own procedures... and to issue appropriate orders."

WHEREAS, the Administrative Procedures Act (MCL 24.207(h)) defines the interpretive statement as a category of agency action which in itself does not have the force and effect of law but is merely explanatory to be followed by the agency.

AND, WHEREAS, The Michigan Supreme Court has ruled in Clonlara, Inc. v. State Board of Education, 442 Mich. (1993). that "agencies have the authority to interpret the statutes they are bound to administer and enforce." And that Interpretive statements "state the interpretation of ambiguous or doubtful statutory language which will be followed by the agency unless and until the statute is otherwise authoritatively interpreted by the courts."

The Commission directs that Interpretive Statement 2018-1 shall be distributed to all Department of Civil Rights' offices, be filed with any other office as required by the Administrative Procedures Act.

Resolution – Support for Francis Anwana remaining in the U.S., Commissioner Smith

Whereas, Francis Anwana ("Mr. Anwana") was born in Nigeria 48 years ago, and

Whereas, Mr. Anwana was born deaf and with cognitive impairments, and

**Whereas**, finding that there were no programs for the deaf in Nigeria and observing that his son was being subjected to harassment because of his disabilities, Mr. Anwana's father first brought his son to the United States at age 13. and

**Whereas**, growing up, Mr. Anwana attended the Lutheran School for the Deaf in Michigan, and later the Michigan School for the Deaf, where he learned American Sign Language, which remains his only effective means of communication, and

**Whereas**, after Mr. Anwana's father passed away in 2012, he continued to live in supportive living situations as he had previous to that time. At no time has he hidden or tried to evade authorities and he has reported regularly to immigration officials as required, and

**Whereas**, due to Mr. Anwana's disabilities, he lacks understanding of the concept of immigration status and his advocates and caregivers were unable to secure stable, permanent immigration status for him when his student status ended, and

Whereas, Mr. Anwana's advocates have continued to attempt to obtain necessary documents permitting him to remain in this country, those efforts have not yet been successful. Still, Mr. Anwana has fully cooperated by making annual appearances before immigration officials, and Whereas, Mr. Anwana voluntarily appeared at the Immigration and Customs Enforcement offices when summoned by letter on September 6, 2018, and was informed that he was to return in five days to be deported, and

**Whereas**, ICE officials recently granted a stay of removal of Mr. Anwana for a period of twelve (12) months in light of the extenuating circumstances, and

Whereas, it appears Mr. Anwana, who has cognitive difficulty understanding the full complexity and seriousness of his situation under the best of circumstances, has (likely in violation of the Americans with Disabilities Act) not been provided by the government with a certified interpreter when meeting with ICE officials and answering questions or being provided instruction, and has instead been required to "bring his own" interpreter, and

Whereas, deporting Mr. Anwana to Nigeria would almost certainly have catastrophic consequences for him as his only means of communication is in American Sign Language. Further, his cognitive challenges not only make acquiring a new language (Nigerian Sign Language) exceptionally problematic, they render him unable to fully understand the implications of being relocated, and incapable of providing the necessities for a new life in what to him is a foreign country, and

**Whereas**, the State Department issued in early 2018 a travel advisory (the third of four levels) to Nigeria and deporting Mr. Anwana to Nigeria will expose Mr. Anwana to serious physical danger such as assault, rape, kidnapping, terrorism and piracy.

It is therefore resolved that the Michigan Civil Rights Commission calls upon officials at every level of state and federal government to recognize the unique situation presented by Mr. Anwana's deafness, his cognitive disability, and his lack of personal responsibility for the failure to properly renew his documentation, and take all actions necessary to permit Mr. Anwana to remain permanently in Michigan and live his life free from the dangers to his health, safety and wellbeing that would be presented by a forced relocation to a country he does not know and that the United States Department of State considers to present serious risks to personal safety and security.

MOTION: Move to Adopt the Resolution in support of Francis Anwana remaining in the U.S. On Motion duly made (Commissioner Demashkieh) and supported (Commissioner Smith), the Resolution in support of Francis Anwana remaining in the U.S. was Adopted. *Motion carried unanimously.*

Whereas, William C. "Bill" Brooks worked for the federal Office of Management and Budget as an operations research analyst during the presidential administration of Richard M. Nixon, and Whereas, William C. "Bill" Brooks worked at General Motors in the 70s and 90s, and Whereas, William C. "Bill" Brooks was nominated to serve as the undersecretary for Labor by President George H.W. Bush, and did serve in that position from 1989 until 1991, and

**Whereas,** in the 90s, when William C. "Bill" Brooks rejoined General Motors as vice president of corporate affairs, he also served as chairman of the General Motors Foundation and chairman of the board and president of Motor Enterprises, Inc., a small business investment subsidiary of General Motors, and

**Whereas,** President William J. Clinton appointed William C. "Bill" Brooks to serve on the Social Security Advisory Board from 1995 to 1998, and

Whereas, William C. "Bill" Brooks retired from General Motors in 1997, and

**Whereas,** during his tenure at General Motors, William C. "Bill" Brooks led the fight to secure equitable access to contracts for small businesses owned by African-American entrepreneurs, and

Whereas, in addition to years of corporate and government service and leadership, William C. "Bill" Brooks spent countless hours creating and nurturing many civic organizations including being a founding member of the National Black MBA Association's Detroit chapter, founding chairman of the Michigan Black Chamber of Commerce, and served time as a member of the boards of the Michigan Opera Theatre and the Music Hall Center for Performing Arts, and Whereas, William C. "Bill" Brooks was a fierce advocate for education particularly for the youth of Detroit, demonstrated by his service on the Detroit Public Schools as a member and chair; and

Whereas, William C. "Bill" Brooks leaves a lasting legacy of striving for equity, equality and success for Detroit, Michigan and the United States,

**Therefore, Now Be It Resolved,** that the Michigan Civil Rights Commission commemorates William C. "Bill" Brooks' life and contributions to the state and beyond, and

Further, Be It Resolved, the Commission recognizes the lasting legacy of William C. "Bill" Brooks on business, government and charitable organizations across the United States, and Be It Further Resolved, that Commission expresses its deepest condolences to his wife of 62 years, Elizabeth; his three children William C. Brooks, Jr., Patricia Elizabeth Brooks and Pamela (Peter) Tully; his eight grandchildren and four great children; and

**Finally, Be It Resolved** on this 8<sup>th</sup> Day of October 2018, the Michigan Civil Rights Commission honors and recognizes, lauds and applauds the legacy left for all Michiganders to follow by the life of William C. "Bill" Brooks.
