

SUBJECT: 2013-14 McKinney-Vento Homeless Students Assistance Grant Awards
ADDITIONAL INFORMATION

Understandably, agencies have contacted MDE asking for additional information regarding the unexpected decline in funding levels for the 2013-14 McKinney-Vento Homeless Grant. The significant drop in the award amount did not result from grant recipient mismanagement. Rather, three factors came together to adversely affect funding available for the 2013-14 awards:

1. Sequestration;
2. Depletion of prior year unspent funds which had been awarded to Michigan grant recipients in recent years;
3. A funds transparency issue that exists between CMS reports and the MEGS+ application process.

Together, these resulted in a decrease in funding in the range of 50% for most agencies when compared to their 2012-13 award.

To assist grant recipients who want and need to know how **future** funding will be affected, MDE is providing agencies with a **2014-15 ESTIMATED** award attached below. This estimate offers a reasonable approximation of what to expect next year, **with the caveat that the estimate assumes no additional funds will be lost due to sequestration, and that the federal award amount for this grant will remain essentially unchanged**. The 2014-15 **individual** agency award amounts will also be affected by the total state count of homeless students and how that count is distributed throughout the state, as is the case in every grant year.
