

SUBJECT: 2014-15 Section 31a Program Report due July 15, 2015

Local Educational Agencies (LEAs) receiving Section 31a At-Risk funds are required to submit the 2014-15 Section 31a Program Report by July 15, 2015. The 2014-15 Section 31a Program Report is available in Michigan Electronic Grants System Plus (MEGS+) at <https://mdoe.state.mi.us/MEGSPlus>. The LEA's MEGS+ Authorized Official (Level 5) or the assigned Application Administrator (Level 4) can initiate the Section 31a Program Report in MEGS+. The MEGS+ Authorized Official (Level 5) can submit the Section 31a Program Report.

For 2014-15, the following new reporting section is added in Section 1, District Compiled Report:

- E: A district may use up to 100% of the funds it receives to implement schoolwide reform in schools with 40% or more of the pupils identified as at-risk by providing supplemental instructional services consistent with the School Improvement Plan.

If the 2014-15 Section 31a Program Report is not submitted by July 15, 2015, an amount equal to the LEA's Section 31a August installment will be withheld from the August State Aid payment as required by the language in Section 31a of the State School Aid Act. These funds will be forfeited if the Report is not received by September 30, 2015.
