To receive a **July 1, 2018** obligation date, local educational agencies (LEAs) must submit the Title IV, Part A SSAE application on or before **July 1, 2018**. For LEAs that submit their Title IV, Part A SSAE Application after July 1, 2018, the obligation date for 2018-19 will be the date of submission in MEGS+.
