Big Ideas for the Framework

- Make team-based decisions, even for ELs
- Make individual student decisions
- Provide supports that the student uses in their regular instruction



Supports and Accommodations Framework

Universal Tools

Available to all students-use is primarily student driven

Designated Supports

 Available to students who have a specific need-use is primarily educator driven

Accommodations

 Available to students with disabilities or those who have 504 plans whose need for the accommodation is documented in IEP/504 plan

- Student Supports and Accommodations Table
 - The table is organized by test and content area
 - Each content area is organized by Universal Tools, Designated Supports, and Accommodations
 - Shows what is allowable

What should I write in an IEP?

- The type of category a support is in for a student doesn't matter
- The Universal Tool, Designated Support, or Accommodation should be on the IEP



Universal Tools, Designated Supports, and Accommodations

- All available Universal Tools, Designated Supports, and Accommodations are the same for 11th grade M-STEP Science & Social Studies

Important Differences

- There are some differences in what is available for Science and Social Studies as compared to M-STEP Math and ELA:
 - For any student who needs a Designated Support Read-Aloud (an in person human reader to read aloud the questions) they must take the paper/pencil test AND the human reader MUST use the Reader Script.
 - For any student who needs the test translated into another language, they must take the paper/pencil test AND the translator MUST use the Reader Script as a guide from which to translate questions.



Important Differences

- No stacked Spanish option is available. However, students could take the paper/pencil test AND use the Spanish DVD or Arabic DVD.
- Text-to-speech is ONLY a Designated Support. There is not a text-to-speech option that is an Accommodation.



How do I know what to use?

- Start by examining what you're doing in the classroom
 - Which students need extra time?
 - Which students need additional audio stimulus when they're reading?
 - Which students are English Learners and may benefit from a wordto-word bilingual glossary in the classroom?
 - Which students may be able to show the most about what they know if classroom content is fully translated for them?
 - Which students may need a scribe?



Remember

- Universal Tools, Designated Supports, and Accommodations are not intended to overly advantage students.
- They are designed to level the playing field.
- What does a student NEED in order to access content and show what they know?



How do I organize everything in advance of the test day?

- Review your class list (or ask your teachers to each review their own)
- Make a list of which students need what supports
- Ensure that the Universal Tools, Designated Supports, and Accommodations are available to students on the day of the test
 - This may mean that someone needs to be the designated point person to enter the information into eDIRECT



How do I enable supports for M-STEP and MI-Access?

- Directions for turning on Designated Supports and Accommodations can be found in the Test Administration Manuals
- Embedded features must be enabled in eDIRECT
- Some features require enabling before printing tickets
