Instructions for Accessing and Downloading Your School Index Report and Accountability Student Datafiles on MI School Data

Obtaining Access to Secure School Index Information

- 1) The Michigan School Index System reports and accountability student datafiles will be **AVAILABLE** the first week of December for 2018-2019 school year results to authorized users of MI School Data (www.mischooldata.org). Authorized MI School Data users will be able to preview accountability results until early December. Accountability data and results will be embargoed until School Index results are public in **December 2019**.
- 2) Accountability user accounts on MI School Data are only necessary if you plan to download student-level data files or create and submit accountability issues or concerns regarding the accuracy of your school/student data. Existing MI School Data users will already have access to view their School Index reports on MI School Data and do not need to do anything further.
- 3) Please review the table below to help you determine if you will need additional access or to have a new MI School Data account created. If you accessed accountability results during last cycle’s preview window, you should not need to do anything further to access the 2018-19 results. Simply login to MI School Data during the preview window.

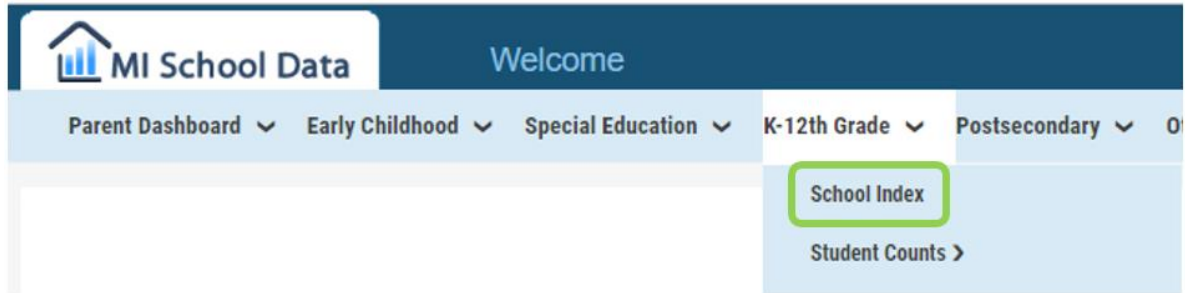

| I DO NOT HAVE a user account on MI School Data and DO NEED access to student-level accountability data files or the ability to submit accountability issues. | Contact your ISD Accountability Administrator to have a MI School Data Account created |

Please note that OEAA Secure Site user accounts do not permit access on MI School Data.

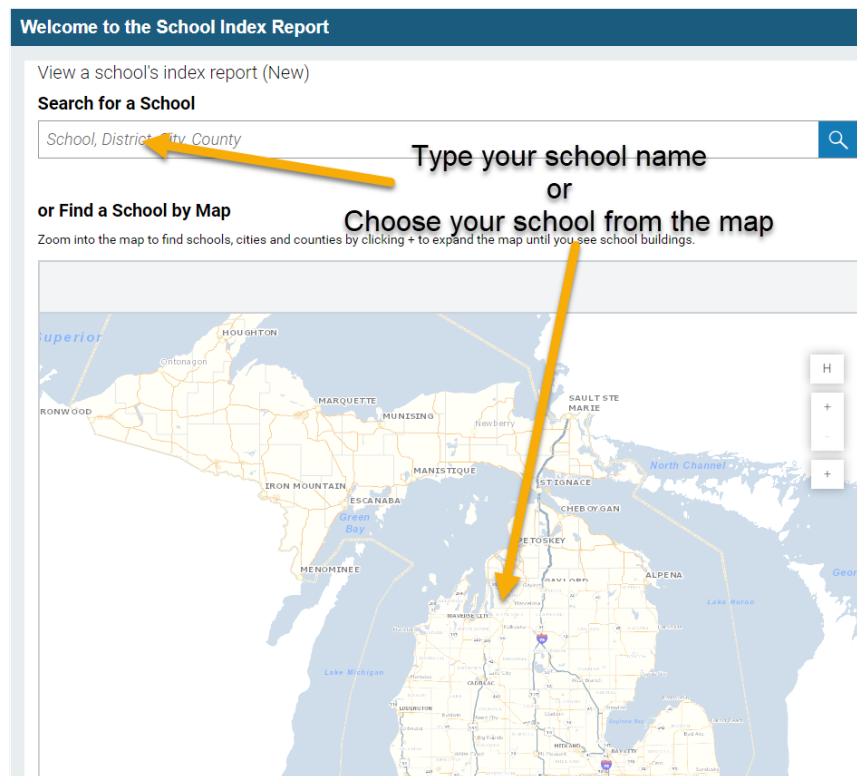

Navigating to Embargoed School Index Report Information

- 1) Once, you have a secure user account for MISchoolData, to view embargoed School Index reports, please navigate to the “School Index” menu item from the “K-12th Grade” menu.



- 2) Search for the School Index report for your school, using the text search box or map feature.




- 3) If you search for your school using the text search box, schools with matching names will appear in the list below. You are then able to click on your specific school in the list to be taken to view its School Index report.

Downloading Accountability Student Datafiles

- 1) If you have a secure MISchoolData account and are now set up as an “Accountability User” role for your school or district described in the “Obtaining Access” section at the beginning of this document, you will also be able to download student information used in School Index Report calculations, click the “Accountability Downloads” link near the top of the School Index Report. Alternatively, you can choose “Other & Data Files” → “Accountability Review” → “Accountability Downloads” using the navigation menus.

Create Accountability Issue Download Results

- A. **Summative Accountability Student Data File** – This option downloads the student-level data necessary to replicate and verify the assessment participation, proficiency, and growth information for M-STEP, MI-Access and SAT assessments in the aggregated Accountability Report file. If “All Schools” is selected in the school drop-down box, student-level accountability data for all schools within a district will be downloaded (for district-level authorized Secure Site users). **The data in this file contains individual student data and may not be shared with unauthorized individuals.**
- B. **English Learner Accountability Student Data File** – This option downloads the student-level data necessary to replicate or verify the assessment participation, proficiency, growth, and progress information for WIDA-Access assessments in the aggregated Accountability Report file. If “All Schools” is selected in the school drop-down box, student-level accountability data for all schools within a district will be downloaded (for district-level authorized Secure Site users). **The data in this file contains individual student data and may not be shared with unauthorized individuals.**

A link to the student data file(s) indicated by check mark will be downloaded in separate .CSV files, emailed to you individually. - 1) If you have a secure MISchoolData account and are now set up as an “Accountability User” role for your school or district described in the “Obtaining Access” section at the beginning of this document, you will also be able to securely submit concerns or issues regarding your Accountability School Index Report or Accountability Student Data Files, click the “Accountability Issues” link near the top of the School Index Report. Alternatively, you can select “Other & Data Files” → “Accountability Review” → “Accountability Issues” using the navigation menus.

- On the Accountability Issues screen, Accountability Users can submit new issues and view the status of already-submitted issues using this screen. Accountability Issues submitted in MI School Data will be reviewed by MDE Accountability staff within one week of submission. Click the "Create Accountability Issue" button on the lower right corner of the screen to report and aggregate or student-level issues or concerns you may have with you School Index reports.
