### **KEY INFORMATION Unanticipated School Closure (USC) Summer Food Service Program (SFSP)**

The Michigan Department of Education (MDE) Child and Adult Care Food Program (CACFP) welcomes you to April 2020. March was a different month for us all with the mandatory closure of Michigan schools on March 16, 2020 and the Stay Home, Stay Safe Executive Order issued by Governor Whitmer that took effect March 24, 2020 mandating Michigan residents stay at home. Many businesses had to close while many schools rushed to feed hungry kids in their communities. Many essential childcare workers took care of essential workers' children to help care for those most at need. Thank you for all that you are doing to care for Michigan's residents.

**In the event of unanticipated school closures (extreme cold day, snow day, water main break, frozen pipes, electrical issues, flooding, natural disasters, illness, etc.) Sponsors may participate in Unanticipated School Closure SFSP. Due to the mandatory closure of all Michigan K-12 schools, the MDE is allowing all Sponsors who participate in the National School Lunch Program (NSLP), School Breakfast Program (SBP), and SFSP to serve meals during this time.**

**During this mandatory closure meals/snacks served must meet the SFSP meal pattern and are not required to be consumed onsite (congregate feeding). Schools and sponsors that participate in Unanticipated School Closure SFSP help ensure children do not experience a lapse in food security now that schools are closed through April 13, 2020. This e-Portal class is free and is suitable for School Nutrition Managers, School Nutrition Directors, Child and Adult Care Center Employees/Staff, Family Child Care Sponsors and Homes.
