



# Child Nutrition Programs (CNP) News and Updates

September 8, 2021

## Supply Chain Guidance

For School Year 2021-2022, MDE is aware there are significant out of stock issues in the supply chain, which may affect the ability to serve the required meal components for lunch and breakfast each day.

To claim reimbursable meals in the National School Lunch Program (SSO included), Sponsors must provide milk, fruit, vegetable, grain and meat/meat alternate in the proper portions.

- Milk is white fat free, white 1% or chocolate fat free. Chocolate 1% may be served to children over 6 if your school is approved for the waiver ([part 1](#)).
- Fruit can be fresh, canned, frozen or juice.
- Vegetables can also be fresh, canned, frozen or juice. Vegetable sub-groups must be met unless your school has been approved for a waiver ([part 2](#)). Vegetable sub-groups include:
  - Dark Green
  - Red/Orange

- Starchy
- Beans/Peas/Legumes
- Other
- All grains must be whole grain-rich. If your school is approved for the waiver ([part 1](#)), then half of the weekly servings may be whole grain-rich.
- Meat/meat alternate – CN labels or Product Formulation Statements (PFS) or the [Food Buying Guide](#) are needed.

To claim reimbursable meals in the School Breakfast Program, Sponsors must provide milk, fruit (or vegetable), and grain (may also include meat/meat alternate).

To claim reimbursable meals in Child and Adult Care Food Program (Preschool or At Risk After School meals), Sponsors must provide milk, fruit, vegetable, grain and meat/meat alternate in the proper portions.

- CACFP meal pattern flexibility waiver [request form](#) is available for whole grain-rich, implementing ounce equivalents and flavored milk.

The **planned menu** should meet the nutritional requirements. If/When supply chain substitutions happen, the Menu Planner **is not required** to recalculate the calories, fat and sodium based on the substitutions at this time. Focus on meeting the meal pattern with the required components. As long as the meal pattern is met, the meal is reimbursable.

Documentation of the supply chain issue is required. This includes:

- Distributor receipts showing out of stock items and substitutes
- Email communication (or phone calls)
- Production records showing menu changes

Meal Pattern Flexibility Waiver Requests can be based on supply chain issues. Waiver approvals are valid for the 21-22 School Year.

Remember to follow the Sponsor's emergency procurement process that is included in their procurement procedures. Texas Department of Agriculture created a helpful document about [procurement during supply chain disruptions](#).

Be sure to communicate with families that meal substitutions may occur because of supply chain issues, especially those families with food allergies. This could be done on menus, school websites and social media.

## Grant Opportunities

### School Year 2022 Fresh Fruit and Vegetable Program Grant is Available

The Michigan Department of Education (MDE) is pleased to announce that the Fresh Fruit and Vegetable Program (FFVP) application is now available for School Year (SY) 2022. Completed application forms are due to MDE by 5:00 pm (EST) **Wednesday, September 22, 2021**.

The FFVP grant is a competitive grant based on free and reduced-price meal eligibility.

#### Eligibility

- Eligible sites include those buildings with elementary students (K-grade 6).
- Buildings with elementary students and students in grades 7 and higher may apply but must ensure that **ONLY** K-6 grade students receive the FFVP snacks.
- High schools, middle schools with grades 7, 8, and/or 9 only, and pre-K only sites are **not** eligible to apply.
- Residential Child Care Institutions (RCCIs) may participate, provided they operate an elementary school program during the day.

- Based on past grant awards, only sites with free and reduced-price eligibility at 85% or higher have been approved.
- MDE is using October 2019 fall data (SY 2019-2020) to determine the SY 2022 FFVP grant awards.

## **2022 NSLP Equipment Assistance Grant is Now Available in NexSys**

The 2021 Agriculture Appropriations Act authorized funds that allow MDE to competitively award Equipment Assistance Grants (EAG) to eligible School Food Authorities (SFAs) participating in the National School Lunch Program (NSLP). The department received over \$700,000 in federal funds for distribution to SFAs.

### **Who Can Apply?**

Any SFA participating in the NSLP or SSO NSLP including:

- Public School Districts
- Public School Academies
- Intermediate School Districts
- Nonpublic School Districts
- Residential Child Care Institutions

### **Application Timeline**

**The grant application opened August 30, 2021, in [NexSys](#).** To complete the grant application, users need to create a MILogin for Third Party account and link that account to their current MEIS account. This is a requirement and is the first step in the transition to the new system. If you haven't done this already, please do so as soon as possible using the [Creating a MILogin for Third Party Account](#). More information about NexSys can be found on the MDE NexSys [website](#). Grant applications are due by 11:59 pm on Friday September 24, 2021. It is expected that grant funding will be awarded by October 15, 2021.

### **Grant amounts:**

Maximum: \$25,000 per building/site

Minimum: \$1,000 per piece of equipment, not in the aggregate

These values do not include the cost of installation and/or any delivery fees.

## Frequently Asked Questions

**Question:** Where can I get help with completion of the SNP Application?

**Answer:** Sponsors should first reference the [Application Quick Start Guide](#). In addition, the [SNP 2022 MEGS+ Application Site Page Instructions](#) can be used for step by step instructions for completing each site page. Questions can be directed to your county's [SNP Analyst](#).

---

**Question:** I have a K-12 building that has multiple building codes. How do I ensure all enrolled students are accounted for in our School Nutrition Program Application?

**Answer:** All brick-and-mortar school sites that have students enrolled under them must be added as a site in the application. This would include K-12 buildings where three separate building codes exist for the elementary/middle/high school students. Even if all three building eat in just one combined cafeteria.

---

**Question:** How do I answer the Indirect Cost Rate question on the Sponsor Information Page?

**Answer:** Public Schools and Public School Academies should answer "Yes" to 13d (Public School Rate) – every Public School and Public School Academy has an approved unrestricted indirect cost rate and no additional documentation needs to be uploaded. Non-Public Schools, RCCIs or brand-new Public School Academies should answer "No" to 13d. Then you will be required to answer 13a. This answer should be "0" unless you have a negotiated indirect cost rate from another Federal Agency/Entity. If the indirect cost rate is anything other than "0", you will need to answer 13b and 13c.

---

**Question:** Should I participate in the Seamless Summer Option (SSO)?

**Answer:** All eligible sponsors should participate in SSO. SSO allows all sponsors to feed all children at the higher free, [Summer Food Service Program rates](#) and eliminates the need to collect payment for reimbursable meals.

---

**Question:** Do I have to offer meals to my virtual/remote students?

**Answer:** Per USDA, only sites that are a brick-and-mortar building can be added as a site in the NSLP/SSO application. Thus virtual or cyber schools that do not have a brick-and-mortar building cannot be a site under NSLP/SSO. For school year 2021/2022 virtual or cyber school enrolled students can have access to meals from open SSO sites. It is a local decision if a district offers an open site. Virtual students enrolled in an NSLP/SSO eligible brick-and-mortar building must be offered meals. This could be done through a pre-order system or as an open curbside pick-up. This would also apply to students who may become remote learners during school year 20021/2022 due to temporary school closures.

---

**Question:** Can I do home delivery for NSLP/SSO?

**Answer:** Home delivered meals are allowable in NSLP/SSO for students enrolled in a brick-and-mortar eligible NSLP/SSO building. Home delivery would not be available for students not enrolled in a brick-and-mortar NSLP/SSO building.
