Communicating for Student Success

Good communication between parents and the school district is critical in working together to meet the educational needs of students. How parents and schools communicate with each other plays an important role in planning for the education of students with disabilities. However, sometimes communication challenges may need to be addressed with additional support. Facilitators and mediators support collaborative conversations to help build a foundation for student achievement. The value of mediation is recognized by the *Individuals with Disabilities Education Act* and the Michigan Department of Education Office of Special Education. Facilitation and mediation services are available free of charge through Special Education Mediation Services (SEMS).

Facilitation

To ensure your voice is heard at special education meetings, you can request help from a trained, neutral facilitator. A facilitator can support the process in special education meetings so discussions are collaborative and everyone at the meeting has a chance to contribute ideas and provide feedback. Any special education meeting can be a facilitated meeting, including individualized education program team (IEP Team) meetings.

Mediation

When there are challenges about an educational issue, such as your child's services or placement, you can request free mediation. Mediation provides a confidential setting for participants to explore options to meet your child's needs. Like a facilitator, a neutral mediator manages a collaborative approach to finding a mutually agreeable solution. If you reach a solution, it is put in a written binding agreement.

Facilitated Meetings and Mediation are:

• Collaborative

Facilitators and mediators guide a productive discussion. Mediators do not offer or enforce solutions. Team members make all the decisions.

• Voluntary

You and the school must both agree to have a facilitator or mediator.

• Confidential

Mediation discussions are confidential by law. Facilitated meeting participants can agree to sign a confidentiality agreement at the meeting.

Free

SEMS provides the services at no cost to you or the district.

SEMS Provides Mediation and Facilitation Services

Special Education Mediation Services (SEMS) provides free facilitators and mediators for special education. The SEMS intake team will work with you to understand and prepare for a facilitated meeting or mediation. Facilitators and Mediators Will:

- Remain neutral.
- Keep the meeting on track and centered on your child's needs.
- Document the agreement (at mediation).

Facilitators and Mediators Will Not:

- Give legal advice.
- Be part of the team.
- Advocate for a position.
- Make decisions for the student's education program.
