## FEEDBACK FORUMS: Michigan's Move to the Every Student Succeeds Act (ESSA)

In November and December, the Michigan Department of Education (MDE) will partner with intermediate school districts across Michigan to gather input from educators, advocates, parents, students, and the public regarding specific proposed components of the nation's new federal education law: the Every Student Succeeds Act (ESSA). The feedback gathered at these forums and through online surveys will inform Michigan's final ESSA plan, which will guide how Michigan leverages federal funding to make Michigan a Top 10 education state in the next 10 years. The final ESSA plan will be submitted to the U.S. Department of Education in early March 2017.

"We need to continue to move Michigan's education system forward, and the new federal law provides one vehicle for us to do that," said State Superintendent for Public Instruction, Brian Whiston. "We invite educators – from classroom teachers to district leaders – as well as advocates, parents, and students to help refine Michigan's transition to ESSA."

#### PLEASE COME - YOUR INPUT IS IMPORTANT!

Why should you attend? ESSA replaces the former federal education law, commonly referenced as No Child Left Behind (NCLB). ESSA offers new flexibility to states and opportunities for Michigan to rethink existing systems and structures regarding supports for students and schools, teacher and leader training and evaluations, school accountability measures, state student assessment, and more. These systems affect all families and communities in some way, so it's important to collect a diversity of ideas and voices while developing our state plan.

Local districts were required to serve schools with 75% poverty under NCLB. ESSA gives LEAs the discretion to lower the threshold to 50% poverty for high schools.

## Who benefits from ESSA?

The Every Student Succeeds Act (ESSA) is the newest authorization of the federal Elementary and Secondary Education Act (ESEA), enacted in 1965. ESSA, like earlier authorizations of ESEA, continues a longstanding commitment to providing equal opportunity for all students. ESEA authorizes state-run programs for eligible schools and districts working to raise the academic achievement of struggling learners. ESSA also authorizes and supports programs that address the complex challenges facing students who live with disability, mobility problems, learning difficulties, poverty, or transience, or who need to learn English. Below and on the following page is a list of federal ESEA programs that influence teaching and learning in Michigan. More information can be found in the <u>Comparison of</u> <u>Select Elements of ESEA</u> by the Council of Chief State School Officers (CCSSO).

## **Resources**

The U.S. Department of Education (ED) has recently released non-regulatory guidance in the following ESSA programs:

Title IV, Part A, Student Support and Academic

Enrichment Grants (SSAE)—This new grant program in ESSA focuses on safe and healthy students, and how technology can be integrated into schools to improve teaching and learning. It also emphasizes access to a wellrounded education that includes a wide variety of disciplines – such as music, the arts, social studies, environmental education, computer science and civics. The guidance – which serves as a resource to help support effective implementation of the new grant program – provides examples of allowable uses of funds, discusses the role of state education agencies, details fiscal responsibilities, and identifies local application requirements.

#### Supporting Early Learning through the Every Student

<u>Succeeds Act</u>—For the first time, ESSA includes provisions to promote coordination in early learning among local communities; align preschool with early elementary school; and build the capacity of teachers, leaders, and others serving young children to provide the highest-quality early learning opportunities. Also for the first time, ESSA authorizes Preschool Development Grants to ensure more students across the country have access to high-quality preschool. This guidance is intended to remind state and local decision-makers about the importance of investing in early learning, highlight the opportunities available under the new law to strengthen early education, and provide examples of how states and local communities can support young children's success in school.
