SUBJECT: Individuals with Disabilities Education Act Public Reporting of Data

The federal regulations implementing the *Individuals with Disabilities Education Act* (IDEA) at §300.602(b)(1)(i)(A) require public reporting on the performance of each local education agency on the targets established in the State Performance Plan/Annual Performance Report (SPP/APR) for each of the priority areas (Part B: Ages 3 through 21) in Michigan.

The SPP/APR for Part B of the IDEA 2004 (ages 3 through 21) is comprised of results and compliance indicators. The United States Department of Education, Office of Special Education Programs, requires that each state report district level data. The 2018 Public Reporting data are from the 2015-2016 and 2016-2017 school years. The Part B indicators predominantly reflect data your district submitted to the state. For Part B, the following indicators are being publicly reported:

Indicator 1 - Graduation

Indicator 2 - Dropout

Indicator 3 - Statewide Assessment Indicator 4A - Suspension/Expulsion

Indicator 4B - Suspension/Expulsion by Race/Ethnicity Indicator 5 - Educational Environments: Ages 6-21

Indicator 6 - Early Childhood Educational Environments: Ages 3-5 Indicator 7 - Preschool Outcomes

Indicator 8 - Facilitated Parent Involvement

Indicator 9 - Disproportionate Representation (Child with a Disability) Indicator 10 - Disproportionate Representation (Eligibility Categories)

Indicator 14 - Postsecondary Outcomes

For a two-week period beginning approximately May 9, 2018, local educational agencies, public school academies, and intermediate school districts will be able to preview district level data for children and students ages 3 through 21.

The district level data will be available at www.mischooldata.org on June 1, 2018. Links to the MI School Data Portal will also be available through the Michigan Department of Education website.

Interested individuals without internet access will be directed to their local or intermediate school district for paper copies of district data.
