P.A. 601 (A-F) Quick Reference

- Public Act 601 signed into law December 2018
- Legislation requirements include:
 - Five annual letter grades and three ranking labels, as applicable, for all individual public schools
 - No summative grade/ranking
 - Identification of lowest and highest achieving schools, and schools with consistently underperforming subgroups
 - Alternative education campuses excluded from letter grades and rankings
 - Peer review panel to review and submit a report as mandated by state law to the Michigan Department of Education (MDE) and state legislature

Decision #1: Combined or Separate Letter Grades

The law requires that schools receive a grade for:

- Proficiency in mathematics and English language arts
- Student growth for mathematics and English language arts
- Graduation rate
- English language learner progress
- Comparison to similar schools (on proficiency in mathematics and English language arts)



Discussion: Combined Letter Grades

Option #1:

- One letter grade for each of the following:
 - Math and ELA proficiency
 - Math and ELA growth
 - Comparison to similar schools on proficiency
- Results in 3 grades (plus a grade each for graduation rate and English language learner progress)

Discussion: Separate Letter Grades

Option #2:

- Separate grades for math and ELA proficiency
- Separate grades for math and ELA growth
- Separate grades for the comparisons of similar schools on proficiency in math and in ELA
- Results in 6 grades (plus grades for graduation rate and English language learner progress)

Comparison to Similar Schools

- This is one of the five required grades
- The current matching algorithm for finding similar schools in the parent dashboard uses the following variables:
 - Student/Teacher Ratio
 - Instructional Expenditures per Student
 - Headcount (Student FTE)
 - Percent of Economically Disadvantaged Students
- At the request of the SBE, we will make the following changes for this matching algorithm for the PA 601 comparison among schools:
 - Match on percentage free lunch eligible (a standard of greater need) as opposed to percentage economically disadvantaged (a standard of slightly lesser nee "
 - Add "percentage of students with disabilities" to the match

Decision #2: Adding Additional Grades

- P.A. 601 does not expressly prohibit the addition of grades to the A-F system
- The SBE has raised this as a possible option

Discussion: Ranking Labels

- In addition to the letter grades, there are ranking labels (Significantly Above Average, Above Average, Average, Below Average, Significantly Below Average) assigned for the following under PA 601:
 - Rate of chronically absent students
 - Assessment participation rate (percentage assessed)
 - Student subgroup proficiency compared with corresponding statewide student subgroup proficiency



Discussion: Combined or Separate Ranking Labels

- Assessment Participation:
 - Option 1: Combined math and ELA
 - Option 2: Separate ranking label for math and for ELA
- Subgroup proficiency to statewide student subgroup proficiency:
 - Combination of all subgroups
 - Separate ranking label for up to nine subgroups
- Total number of ranking labels will range from <u>3</u> to <u>12</u> depending on these decisions (see next slide for examples)
