SUBJECT: National School Lunch Program Verification Summary Report

Annually, each Local Educational Agency (LEA) is required to select and verify a sample of its School Year 2009-2010 applications for Free and Reduced-Priced School Meal Program benefits by November 15. The outcome of these verification activities must be reported to the Michigan Department of Education (MDE) via the Web-based Local Educational Agency Review System (LEARS). The LEARS Verification Summary Report is due March 1, 2010.

The Website login for reporting the results of this process was open as of January 15, 2010, and accessible through the MEIS home page at: <http://www.michigan.gov/meis>. A reminder e-mail will be sent to the designated contact(s) in your educational agency that have submitted a Child Nutrition Programs Security Authorization Form to MDE requesting access to the LEARS Verification Summary Report. The Food Service Director designated in your agency's 2009 School Meals Child Nutrition Application Program (CNAP) will also be sent an e-mail notification.

Please check with your staff to make certain that verification has been completed and verification data has been compiled and reported in the LEARS Verification Summary Report **before March 1, 2010**.
