SUBJECT: Michigan Integrated Continuous Improvement Process (MICIP)

Availability to Local Districts

Schools and districts throughout Michigan are grappling with the immense challenge of supporting learning and learners during a pandemic. As instruction is being delivered in-person, through learning at a distance, or a hybrid of the two, schools are engaging in rapid cycles of evaluation and implementation with the goal of ensuring safe, healthy, and supportive learning environments during these challenging times.

The Michigan integrated continuous improvement process (MICIP) will be available to assist districts in their efforts to improve student outcomes beginning January 4, 2021. When districts are ready to transition to the new MICIP platform, the platform will be available for their use.

Districts are required to create school and district improvement plans to meet federal and state requirements for the 2021-22 academic year. Districts that are using the MICIP platform will see advantages and ease of submitting these plans. If a district is not prepared to begin using a new platform, the Michigan Department of Education (MDE) will create a pathway for submission of paper plans for the 2021-22 school year only. Plans for the 2022-23 year will be created in MICIP. For accredited districts, plans created in MICIP will be accepted to meet accreditation requirements through Cognia. Please note that Cognia's ASSIST is no longer available to create district/school plans as of September 30, 2020.
