SUBJECT: Workshop for New Early/Middle College Schools and Programs

On Friday, February 23, 2018, from 8:30 a.m. to 2:30 p.m., the Michigan Department of Education (MDE) and the Michigan Early/Middle College Association (MEMCA) will host a workshop for districts and public school academies interested in starting an Early/Middle College (E/MC) high school entity or program. The meeting will be held on the Campus of Mott Community College - Event Center, 1401 East Court Street, Flint, Michigan 48503. The MDE, MEMCA, and Center for Educational Performance and Information (CEPI) staff will be onsite to share the benefits, various models, and reporting requirements for E/MCs in Michigan.
