## **Top 10 in 10 Goals and Strategies**



### Valid and Reliable Measure

- Ensure all the measures of Core Performance Indicators at the secondary level are valid and reliable.
  - -Validity refers to how well it measures what it is supposed to measure.
  - Reliability is the degree to which the measure is stable and consistent.






Reliable Not Valid

#### What's New in Perkins V Accountability? CTE Concentrator

#### **Secondary**

 A student who has completed at least 2 courses in a single career and technical education program or program of study





#### What's New in Perkins V Accountability? CTE Concentrator

#### **Postsecondary**

- A student who has—
  - Earned at least 12 credits within a career and technical education program or program of study; or
  - -Completed such a program if the program encompasses fewer than 12 credits or the equivalent in total





# What's New in Perkins V Accountability? CTE Participant

 An individual who completes not less than one course in a career and technical education program or program of study





# What's New in Perkins V Accountability? Program of study

A coordinated, nonduplicative sequence of academic and technical content at the secondary and postsecondary level that—

- -Incorporates challenging State academic standards
- Addresses academic, technical and employability skills

#### **Program of study definition (continued)**

- -Aligned with the needs of industries
- Progresses in specificity (Career Cluster to occupation-specific)
- -Has multiple entry and exit points that incorporate credentialing
- -Culminates in the attainment of a recognized postsecondary credential





Recognized postsecondary credential

- Industry-recognized certificate or certification
- Certificate of completion of an apprenticeship
- License recognized by the State of Michigan or Federal Government
- Associate degree
- Baccalaureate degree





# What's New in Perkins V Accountability? Work-based learning

- Sustained interactions with industry or community professionals in real workplace settings; or simulated environment at an educational institution
- Foster in-depth, firsthand engagement with the tasks required in a given career field
- Aligned to curriculum and instruction





#### **Purpose of Accountability Subcommittee**

- Obtain expert input from Michigan educators on CTE measurement and reporting options
- Benefit from discussion and multiple voices in decisions
- Desired outcome: A subcommittee recommendation for each of the key accountability issues presented.

- How to identify secondary concentrators
- Measure of program quality





#### **Secondary Concentrators**

• Perkins legislation defines:

**CTE** concentrator

A student served by an eligible recipient who has completed at least 2 courses in a single career and technical education program or program of study.





#### **Secondary Concentrator**

- States may define "course."
- "Courses"/programs should be equivalent—is an equity issue.
  - -Competencies? Standard measure of competencies.
  - -Number of hours?

    - Reported by colleges (CEPI STARR, Transcript data)
    - Reported by schools in Teacher Student Data Link collection in MSDS





- Currently available data
  - -Postsecondary awards
    - Certificates awarded by colleges
    - Degrees awarded by colleges
  - -Industry-recognized credentials
    - Currently collected in CTEIS by PSN

- Currently collected data
  - –Work-Based Learning submitted in CTE Navigator
    - Not currently in a form that can be compiled for reporting

- State Determined Level of Performance (SDLP)
  - -Not negotiated with USDOE
  - -Set with input from eligible recipients
  - -Subject to public comment





- State Determined Level of Performance (SDLP)
  - -Require the state to continually make meaningful progress toward improving the performance of all CTE students, including special populations





- State Determined Level of Performance (SDLP)
  - -Must be the same for all CTE Concentrators in the state
  - -Must be expressed in a percentage or numerical form
  - -States may not adjust SDLP if under an improvement plan

May 2019	Notify districts of new data to be collected in Fall 2019 to calculate SDLPs for new indicators
Sep-Dec 2019	Collect data for new indicator(s) (if needed)
Dec 2019	Districts submit baseline data for new indicators (if needed)
Dec 2019-Jan 2020	Compute new indicators and SDLPs (if needed)
