SUBJECT: Revised 2014-15 Title III, Part A - Limited English Proficient (LEP) Final Allocations in MEGS+

The 2014-15 final allocations for the Title III, Part A - LEP grant have been revised due to an error discovered in the LEP data in the Michigan Student Database System (MSDS). The revised allocations are posted on the Office of Field Services (OFS) Program Allocations webpage at http://www.michigan.gov/mde/0,1607,7-140-6530_30334-127227--,00.html and are available in the 2014-15 Consolidated Application in MEGS+.

The deadline is January 15, 2015, to apply for your Local Educational Agency's (LEA's) 2014-15 Title III, Part A - LEP funds in order to receive a July 1, 2014, obligation date or the obligation date established for your LEA's 2014-15 Consolidated Application.

If your LEA has already applied for their 2014-15 Title III, Part A - LEP original final allocation in your 2014-15 Consolidated Application, revisions reflecting the revised allocation adjustment and any 2013-14 applicable Carryover funds should be made during the Consolidated Application amendment period.

For LEA *consortium members*, the LEA serving as your fiscal agent will adjust the Title III, Part A - LEP Budget Detail(s) in their 2014-15 Consolidated Application.
