SUBJECT: SE-4107 School Bus Inventory System (SBIS)

The SE-4107 School Bus Inventory System (SBIS) is a web based application utilized by local districts, intermediate school districts, and public school academies to submit data to the Michigan Department of Education on all black and yellow buses used by the district in transporting pupils to and from school. This includes data on all black and yellow vehicles contracted from a third party carrier, such as Dean Transportation and/or First Student.

The SBIS was completely rewritten beginning with the 2011-12 school year moving to a new more user friendly electronic database. The system includes enhanced features to help with the data entry process, such as drop down menus. It also has a sort feature to allow districts to sort their fleet inventory by any of the columns with the Edit/Delete or Transfer Screens within the application.

The SBIS will open for districts to begin to add, delete or edit their fleet inventory beginning October 13, 2014. The SBIS can be accessed through the current MEIS page or by accessing the new link directly at <https://mdoe.state.mi.us/SBIS/Login.aspx>

The SBIS is available until June 30, 2015 for districts to make changes to their bus fleet inventory. Districts will need to certify that their fleet inventory is correct annually. The Certify function is described in the School Bus Inventory User Manual which can be accessed through the MEIS page or at the link below.
