School Children Consumed More Whole Grains Following Change in School Meal Standards

A study by ERS and University of Georgia researchers found that in 2013-14, the whole grain to total grain consumption ratio for the school foods children ate (USDA school meals and non-USDA snacks or meals obtained at school) was 21.5 percent—higher than the 17.2 percent ratio for home-prepared foods and the 2.6 percent ratio for foods from restaurants and fast food places. On January 21, 2020, the USDA Food and Nutrition Service (FNS) published a 60-day notice and request for comments on the proposed information collection for the Determining Eligibility for Free and Reduced-Price School Meals and Free Milk.

In accordance with the Paperwork Reduction Act of 1995, this notice invites the general public and other public agencies to comment on this information collection. Every 3 years, Food and Nutrition Service (FNS) must publish the burden, or time and frequency, of every record-keeping and reporting activity. State agencies and program operators are especially encouraged to comment on the accuracy of these burden estimates to provide important feedback to the USDA and allow for the successful operation of the National School Lunch Program, School Breakfast Program, and Special Milk Program.

Any comments should be submitted by March 21, 2020, through the [Federal Register Notice](#).(7)

Request for Comments on the Proposed Information Collection for the Turnip the Beet! High Quality Summer Meals Award Program.

In accordance with the Paperwork Reduction Act of 1995, this notice invites the general public and other public agencies to comment on this proposed information collection.
