**SUBJECT:** Section 104e-Assessment of Digital Literacy Pilot Project Grant

The Michigan Department of Education (MDE) is pleased to announce the availability of the Section 104e-Assessment of Digital Literacy Pilot Project Grant. The purpose of the grant is to provide a digital literacy preparation pilot project for pupils in grades kindergarten to eight in at least 220 districts. The grant funded under this section is intended to prepare and assess student's digital literacy skills. The project supports the Top 10 in 10 strategic goal two, strategy 2.1, 2.6, 2.7 and 2.8 by:

- supporting the development of a coherent assessment system to support personalization of learning;
- engaging students in well-rounded learning experiences through engagement of digital literacy curriculum;
- providing access to personalized learning technologies that support and enhance those learning experiences; and
- creating an integrated system of guidance that includes curriculum, instruction, and assessment supported by technology with necessary classroom level resources provided.

Eligible applicants are Michigan school districts that operate at least grades kindergarten to eight and has a partnership with a third-party partner that is experienced in the assessment of digital literacy and the preparation of digital literacy skills. The MDE has interpreted school district to include Intermediate School Districts (ISDs).
