## **MEMORANDUM**

- **SUBJECT:** Social Justice & Anti-Racist Educator Efforts and Resources

The Michigan Department of Education (MDE) is pleased to share three efforts to combat racism and promote social justice.

First, the State Board of Education approved a resolution on the eradication of racism and the creation of more equitable and inclusive schools at its June board meeting. You may find this resolution, approved in June at this <u>link</u>.

Second, State Superintendent Dr. Michael Rice convened groups of students and educators, nominated by local superintendents, to engage in discussions about how we can work toward the eradication of racism in our schools with students and educators as partners.

Initial conversations have occurred, and more are expected. MDE is working to flesh out an agenda of the challenges and opportunities identified. This effort includes the sharing of diverse representative literature and instructional materials and practices so that students from all backgrounds can experience educational materials that reflect their race, ethnicity, gender, socioeconomic status, and sexual orientation. Additionally, MDE is working to address any biases of its own by requiring implicit bias training of all its employees.

Third, the Governor's Educator Advisory Council, nominated by Governor Gretchen Whitmer supported by MDE staff, has developed the following two resources.

The <u>Proclamation for Social Justice</u> is a document that serves as a timely reminder of our moral imperative. There should be no inequities among groups of children, least of all based on race. We see these as fault lines that will only exacerbate the problems of our society. We see these discrepancies in education as a call to conscience for us all. Classrooms are some of the most powerful places in the world, and this proclamation is a commitment to the children of our state that we will use our power for good.
