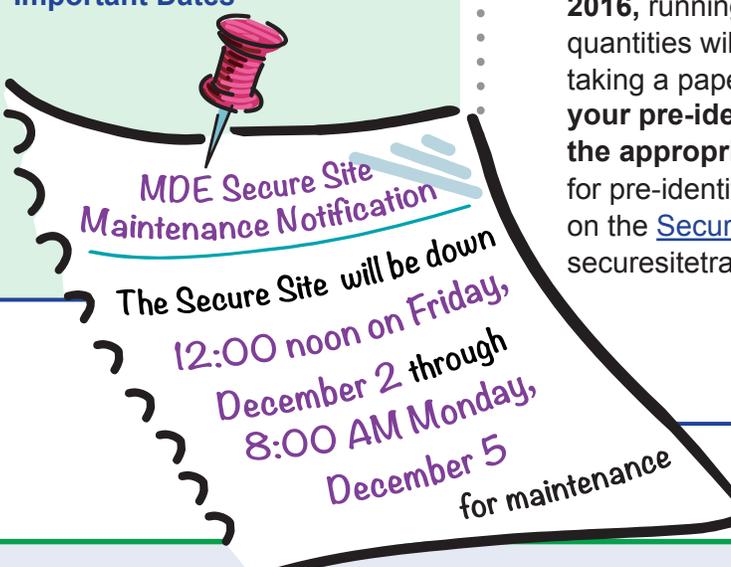
### WIDA Initial Material Order and Pre-ID Window Open

The Michigan Department of Education (MDE) will be pre-identifying, in the Secure Site, all English learner (EL) students (grades K-12) for Spring 2017 WIDAACCESS for ELLs testing using the Fall 2016 MSDS General Collection and Student Record Maintenance (SRM) files submitted through December 6, 2016.

This is a one-time pull for pre-identification purposes for students taking the summative WIDAACCESS for ELLs. The Pre-ID Student Report is expected to be available to schools on **December 8, 2016** in the [Secure Site](#) ([www.michigan.gov/baa-secure](http://www.michigan.gov/baa-secure)). It will be the responsibility of the district and/or school to update the Pre-ID Student Report by un-assigning students who exit the district, and adding students who enroll or are newly identified as EL directly on the Secure Site.

All students identified by any district in an LEP program in MSDS are expected to take the WIDAACCESS for ELLs or the Alternate ACCESS for ELLs.

The Initial Material Order screen to order WIDA Braille and enlarged print will also be available the **week of December 8, 2016**, running through **December 28, 2016**. All other material quantities will be based on pre-identification for those students taking a paper/pencil test. **It is IMPORTANT to make sure your pre-identification is accurate to ensure you receive the appropriate paper/pencil materials.** Detailed instructions for pre-identification and material orders will be available on the [Secure Site Training web page](#) ([www.michigan.gov/securesitetraining](http://www.michigan.gov/securesitetraining)) by December 8, 2016.

## WIDA Test Exceptions

The window for WIDA Test Exceptions will be open from **December 8, 2016 – January 26, 2017** in the Secure Site. This window is a period of time in which educators may request a waiver from the Spring 2017 WIDA ACCESS for ELLs 2.0 or the Alternate ACCESS for ELLs for some students with specific disabilities. All test exceptions must be applied for on an annual basis and approvals do not carry over from year-to-year.

## WIDA Guidance on Pre-ID, Initial Material Order, and Tier Selection

The assessment window for the WIDA ACCESS for ELLs 2.0 (Michigan's annual summative assessment for English Learners) opens **February 6, 2017** and ends **March 24, 2017**. In addition to this assessment, there also exists the opportunity for students with significant cognitive disabilities to take the WIDA Alternate ACCESS for ELLs.

In preparation for both of these assessments, the Pre-ID Student Report is expected to be available to schools on **December 8, 2016** in the [MDE Secure Site](#) ([www.michigan.gov/baa-secure](http://www.michigan.gov/baa-secure)). The Initial Material ordering window in the Secure Site will be

open the week of December 8 and runs through **December 28, 2016**. At that time districts must be prepared to do the following:

- identify tiers (A, B, or C) for students taking the paper/pencil assessment
- identify students who will be taking the Alternate ACCESS for ELLs (Tier T)
- identify whether or not an online test taker will need a paper/pencil book for the writing domain (Grades 4–12 ONLY—available only for students identified as recent arrivals in U.S. schools 12 months or less, or for students with a need identified in their IEP/504 plan necessitating a paper/pencil booklet for the Writing domain)
- identify which students may need accommodations that are only available on the paper/pencil assessment

When attempting to determine if the A, B, or C tier is appropriate for students, educators should refer to guidance found in [Criteria for Tier Selection](#) (<https://www.wida.us/get.aspx?id=288>).

Educators should consider the following criteria when attempting to determine if the Alternate ACCESS for ELLs is appropriate for a student:

1. The student has been classified as EL.
2. The student has, or functions as if they have, a significant cognitive disability and is eligible for special education services under IDEA.
3. The student is working towards alternate achievement standards aligned with Michigan's academic standards. This student also typically participates in MI-Access (Michigan's alternate

accountability assessment). Additionally, it is important to review the [Alternate ACCESS for ELLs Sample Items](https://www.wida.us/get.aspx?id=487) (https://www.wida.us/get.aspx?id=487) to best determine if the assessment level is appropriate for a student.

## WIDA Training and Preparation

Because materials on the wida.us site as well as the Test Administrator Manual that will be shipped to schools are not Michigan specific, educators should review the [Michigan ACCESS for ELLs 2.0 Checklist](http://www.wida.us/membership/checklists/MI-checklist.pdf) (www.wida.us/membership/checklists/MI-checklist.pdf) and follow the outlined tasks.

Test Administrators and Coordinators who are administering the **online** WIDA ACCESS for ELLs 2.0 and were certified for the Spring 2016 WIDA ACCESS for ELLs assessment are not required to recertify. Educators administering the Kindergarten and paper/pencil form of the WIDA ACCESS for ELLs 2.0 are required to recertify.

However, all **new** Test Administrators and Coordinators (for online testing and paper/pencil) must complete the online training modules available through the secure portal on wida.us and pass the associated quizzes with a score of at least 80%. Educators in both roles

do not need to review the following chapters within each of the corresponding modules because they are **not** relevant to Michigan:

- Ordering Materials: **Module may be skipped**
- Test Scheduling: **Chapters 13, 14, 15, 16, 17 may be skipped**

As a reminder, please note that Michigan educators do **NOT** conduct these activities in the WIDA Assessment Management System (AMS):

- Pre-ID students for testing
- order initial materials
- add new students directly into AMS
- create new WIDA AMS users directly in AMS
- update student demographics
- conduct data validation

## New WIDA Test Coordinator and Test Administrator Accounts

With the exception of Technology Coordinators and educators who administered the Spring 2016 WIDA ACCESS for ELLs 2.0, **new** educators who are administering the Spring 2017 WIDA ACCESS for ELLs 2.0 will **not** have access to the online testing management site, the WIDA Assessment Management System (AMS), until the beginning of January. This does not impact training and preparation for the assessment as training modules can be completed through a separate online system on the [WIDA website](http://www.wida.us) (www.wida.us).

### Reminders

1. Off-site testing plans are due December 15, 2016.
2. You can begin applying for College Board accommodations as soon as your school has an AI code and the SSD coordinator has access to the SSD online system. AI codes will be emailed to the test center supervisor in mid-December if you do not currently have an AI code.

### State-Allowed Accommodations (SAAs)

- In addition to College Board Accommodations, the College Board will be supporting State-Allowed Accommodations (SAAs) for students taking the Michigan-provided assessments in April 2017. SAAs are in place to support state-required accommodations that the College Board does not allow for college-reportable scores, such as an English Learner who requires a glossary when taking College Board assessments. SAAs provide scores to students, K-12 educators, and the Michigan Department of Education; however, students who test with an SAA will NOT receive a college or scholarship reportable score.
- When applying for accommodations for SAT, PSAT 10, or PSAT 8/9, we recommend

applying for College Board Accommodations first, unless the accommodation requested is one of the following, as defined by MDE:

- ♦ reading content and questions in the student's native language
- ♦ use of a bilingual word-for-word, non-electronic translation glossary for English language learners
- ♦ signing of the content and test questions in American Sign Language (ASL)
- ♦ student responds in American Sign Language (ASL)
- ♦ extended time for EL learners
- ♦ math-only for first-year EL learners
- All SAAs should be submitted via the [SSD Online system](https://www.collegeboard.org/students-with-disabilities/ssd-online) (<https://www.collegeboard.org/students-with-disabilities/ssd-online>) beginning in January 2017. At that time, once logged in, SSD Coordinators will see a link in the upper left corner to go to the SAA Dashboard. For SAA requests, the submission of student information should be initiated from the SAA Dashboard.
- All SAA requests will be automatically approved and do not require documentation.
- All requests should be submitted by **February 14, 2017**, for SAT for 11th graders, PSAT 10 for 10th graders, and PSAT 8/9 for 9th graders, in order to ensure that the appropriate materials will be provided on test day. SAAs are available only for the Michigan-provided administration.

- For each of the accommodations above, the test will need to be administered in a separate room.

## New SAA for 2017

- The MDE is able to provide certain exceptions to the state assessment policy for first-year, EL students. Students must be identified as Limited English Proficient (LEP) in the Michigan Student Data System (MSDS) and have been enrolled in U.S. schools for 12 months or less at the time of taking a state assessment in order to receive a one-time exemption from having to take the English language arts portion of the SAT, PSAT 10, or PSAT 8/9. For more information on MDE's policy, go to the [MME web page](http://www.michigan.gov/mme) (www.michigan.gov/mme). This exception means that a student only needs to take the math test of the SAT and this will count towards a school's percentage of students tested.
- To apply for the math-only exception, choose EL-Math Only from the State-Allowed Accommodations list. The accommodation will be automatically approved and students will test with a lime-green test book.

- ♦ The SSD coordinator will only use the scripts for the math test in the SSD coordinator manual when administering the test. The test book will include all of the other tests; however, the student will only complete the math test.

## Previous SAA Now a Reportable Score

Last year, the reading of test directions in a student's native language was a SAA. This year, scores will be college and scholarship reportable.

- No accommodation request is required.
- Printed versions of the test directions will be downloadable for educators to distribute to students on test day as needed.
- The languages that will be available to print include: Spanish, Arabic, Haitian Creole, Mandarin, Portuguese, Polish, Russian, and Vietnamese. Printed directions will be available to print on the [Michigan College Board web page](http://www.collegeboard.org) (www.collegeboard.org/Michigan) in the spring.
- If other languages are needed, these can be translated during the reading of the test directions by district-approved translators.

## Receiving Communications for the Spring 2017 Administration

ACT provides important communications to WorkKeys school and district testing coordinators, including deadline reminders and policy information. ACT has received a large number of returned emails from communications sent on October 21, November 7, and November 10. If you are a school or district WorkKeys testing coordinator and did not receive emails on these dates, action is required.

First, confirm the EEM has your most current ACT WorkKeys test coordinator contact information. If the information for your school or district is inaccurate or out-of-date, please ask your authorized district EEM user to update the EEM as soon as possible to ensure your school receives communications from ACT. If you do not know who your authorized district user is, please contact the Center for Educational Performance & Information (CEPI) at 517-335-0505, ext. 3 or [cepi@michigan.gov](mailto:cepi@michigan.gov).

If the EEM is current, but you did not receive communications from ACT, work with your IT department to have the [statetesting@act.org](mailto:statetesting@act.org) email address white-listed. Your school or district firewall settings may be preventing the delivery of ACT communications.
