### M-STEP Parent Reports Are Coming Your Way!

The M-STEP reporting vendor, Measurement Incorporated (MI), will be shipping Parent Reports and Student Record Labels to schools starting Friday, December 11, 2015 using FedEx two-day delivery. Reports will be shipped to the schools where students tested last spring. Reports and labels will be packed and shipped as they are printed. It is MDE's expectation that all reports will arrive in schools by December 18, 2015.

A parent's [Guide to M-STEP: What it Is, What it Means — And What it Offers](#), will be included with each shipment. Please disseminate this guide to parents and guardians along with the Parent Reports. Individual copies of Parent Reports may be printed from the Interactive Assessment Reporting Website beginning December 18, 2015. The reporting website can be accessed by authorized users through the [Secure Site](#) (<https://baa.state.mi.us/BAASecure>). ### A Note About Claim Scores in the 2015 M-STEP Data Files and Reports

Please be aware that student claim scores are calculated differently, on a different scale, than a student's overall score for English language arts, or mathematics. **Claim score information on reports is meant to be a visual indicator of a student's progress in that particular claim.** A green checkmark indicator means the student is "Near/At" or "Above" proficiency for that

claim. A red X indicator means that student is "Below" proficiency for that claim.

Given the fact that claims scores are calculated differently than a student's overall score, please do NOT attempt to make comparisons between claim scores and an overall score. **Example: Do not try to average, or add, claim scores to equal an overall score.** Please use claim scores as an indicator or "snapshot" of how a student is doing in each claim.

Claim score reporting is a new area of reporting for MDE and we will continue to refine it over the coming years.

  - ▶ scratch/blank paper (MUST be securely disposed of)
  - ▶ clarification of test directions in student's native language
  - ▶ untimed test

## MI-Access Essential Elements Documents Update

The Office of Standards and Assessment has been reviewing feedback received from the field and from the public regarding the new alternate content standards. Based on this feedback and review, the draft Essential Elements with Michigan Range of Complexity for English language arts (ELA) and mathematics are being revised. Revised draft documents for grades K–5 are now available on the [MI-Access Web page](http://www.michigan.gov/mi-access) (www.michigan.gov/mi-access). Under the **What's New** section, click on the **Essential Elements with Michigan Range of Complexity** link. The new draft documents are listed on the site by grade level and content area. These documents

replace the previous crosswalks found on the site. Revised documents for grades 6–12 will be provided as soon as review and revision of these grade levels are complete.

**Only the language of the Michigan Range of Complexity (High, Medium and Low) have been revised.** The target Essential Elements have not changed.

**Please note that the Spring 2016 MI-Access English Language Arts and Mathematics assessments will be based on these draft Essential Elements with Michigan Range of Complexity.** Please take steps necessary for teachers to be able to access these draft standards as soon as possible.

## SAT Corner

*Information on SAT™, PSAT 8/9™, and PSAT10™ provided by the College Board*

### Update to Administration Start Time Policy

#### SAT

The College Board has been working with MDE to reconsider our testing time requirements to help address the resource challenges that some school officials have raised. For SAT with Essay, testing is scheduled to begin at 8:30 AM ET. Schools may alter the start time by 30 minutes and therefore start any time between 8:00 AM and 9:00 AM ET. Schools must contact the SAT School Day Customer Support for consideration and approval to start earlier than 8:00 AM or later than 9:00 AM ET. The start time applies to standard test takers as well as accommodated test takers in both the primary and makeup administrations.

#### PSAT 8/9 and PSAT 10

For PSAT 8/9 and PSAT 10, the standard policy is for testing to begin early enough to complete testing before noon ET. Both assessments last approximately three hours not including pre-administration activities. **Schools cannot break for lunch and then resume testing. The College Board recommends that testing be completed in the morning; however, we will support afternoon testing for the statewide Michigan administration only.** Please note, all standard College Board policies will apply to any testing outside of the state-sponsored administration. Afternoon testing is NOT allowed for SAT with Essay.

For PSAT 8/9 and PSAT 10, schools may test on either April 12 or April 13, 2016 in either the morning or afternoon without pre-approval

from College Board. **Schools must test all students in the same grade at the same time.** The tests must be administered in one sitting and be completed before the end of the school day. The start time applies to students testing with accommodations as well—though **accommodated test takers may test anytime during the April 12 – April 27, 2016 test window.**

## Off-site Testing Requests – Please Submit by January 15, 2016

Most schools participating in the April 2016 Michigan-sponsored test administrations will use their schools as the test location. However, if you need more space—for example, if your school is a virtual school, or if you want to administer the PSAT 8/9, PSAT 10, and SAT with Essay

on the same day and don't have enough room in your school—you can request an off-site testing location.

Once you have identified a potential facility, the first step is to complete the Testing Plan template. A separate plan is required for each off-site location. **To request an off-site testing location, go to the “K-12 Educators” section of our [Michigan website](http://www.collegeboard.org/michigan) (www.collegeboard.org/michigan).** Look for the **Requesting an Off-Site Testing Location** section for instructions and to download the Testing Plan template. All off-site testing location requests must be received **no later than January 15, 2016**, in order to allow sufficient time for processing prior to test administration day.
