### WIDA AMS Accounts

Accounts for the WIDA Assessment Management System (AMS) will be generated based on roles assigned in the MDE Secure Site. Educators coordinating and administering the WIDA ACCESS for ELLs 2.0 and WIDA Alternate ACCESS for ELLs assessments will need a WIDA AMS account in order to complete the following testing activities as appropriate:

- manage online testing sessions
- print test tickets
- order additional materials
- monitor completion of testing
- add/assign accommodations
- view score reports

## MDE's Early Literacy and Mathematics Benchmark Assessments-Online Only

MDE's Early Literacy and Mathematics Benchmark Assessments will be available this Spring 2017 for Kindergarten, grade 1, and grade 2, from April 10, 2017 through May 26, 2017. To prepare students for the Online Assessments, teachers should provide the opportunity for students to view the student tutorial and practice the Online Tools Training.

## Online Resources

### Student Tutorials

The Office of Standards and Assessment (OSA) has created Student Tutorials. These student-narrated videos introduce teachers and students to the online tests and tools contained in the Early Literacy and Mathematics Benchmark Assessments. The Student Tutorials are designed to be administered in a group setting, such as the classroom. The tutorials can be accessed on [eDIRECT](https://mi.drccedirect.com/default.aspx) (<https://mi.drccedirect.com/default.aspx>), by selecting **All Applications** → **General Information** → **Test Tutorials**. Click on the icon under the Action column. This takes you to the tutorial page. The student tutorials can also be accessed in **INSIGHT**. Open **INSIGHT** and on the bottom of the page select the **DRC INSIGHT Online Assessments Tutorials** link.

An important component of the Student Tutorials is that they provide explicit training on the pause, exit, end test functionality of the online testing engine. In addition, the tutorials explain how to access and use specific tools.

OSA recommends that classroom teachers introduce online testing to their students by playing the Student Tutorial video in class to show students how the online testing system and tools work. Once the Student Tutorial video is shown and discussed in the classroom, teachers then schedule time to show the **Online Tools Training (OTTs)** to the entire class. After the students have seen the Tutorial and the OTTs led by the teacher, each student can be provided hands-on practice through the use of the online Sample Item Sets contained within the Online Tools Training (OTTs) described below.

### Online Sample Item Sets and OTTs

Another important resource schools can access are Online Sample Item Sets for students in grades K–2. Sample Item Sets are a select group of test items in early literacy and mathematics that encompass various kinds of technology-enhanced items (drag and drop, hot spots, etc.). The sets provide students practice in solving grade-level and content-specific test items aligned to Michigan's content standards and provide practice navigating the online test delivery system.

Feedback collected from previous test administrations indicates that students and teachers who utilized the OTTs and Sample Item Sets felt more prepared for online testing. Students reported feeling confident about taking assessments online, and school administrators and teachers said they experienced fewer issues related to online testing than students and teachers who did not take advantage of this resource.

The OSA has developed online resources for students taking state assessments at all grade levels. The resources support the idea that students can learn about online technology when teachers and other educators demonstrate the use of technology (student video tutorial, classroom viewing of the OTTs), followed up by interaction with students while they are practicing individually with technology (OTT). The OSA welcomes your feedback about the available resources.

## iPad Issue Resolved

## New Science Pilot for Spring 2017

The Michigan Science Pilot Assessment will be available for Spring 2017 testing for students in grades 5, 8, and 11. This assessment is based on Michigan's recently adopted K-12 Science Standards. The Michigan Department of Education (MDE) is seeking schools and districts to volunteer to participate in the Science Pilot Assessment. This assessment is only offered online, and there are no accommodations provided other than typical online tools (highlighter, magnifier, color chooser, etc.). The science pilot will be conducted during the M-STEP testing window, **April 10, 2017 – May 26, 2017.**

Each participating student will be administered one item cluster consisting of a scenario and 5-8 questions. These item clusters are designed to take students


10-15 minutes to complete. There will also be a short survey for students at the end of the pilot assessment. Schools may decide whether an entire class will participate in the pilot, or a subset of the class.

Since this is a pilot assessment, no data will be returned to schools or districts. The data captured will help MDE create a valid operational test for the Michigan K-12 Science Standards in the future.

If your school or district is interested in participating in Michigan's Science Standards (MSS) Pilot this spring, just complete the following steps:

## Pre-Identification

- Participating students in grades 5, 8, and 11 must be pre-identified on the [Secure Site](http://www.michigan.gov/baa-secure) ([www.michigan.gov/baa-secure](http://www.michigan.gov/baa-secure)) to the **Spring 2017 MSS Pilot**. The MDE will **not** pre-identify students for the Spring 2017 science pilot (see Figure 1).



- Pre-identification on the Secure Site is open until **May 26, 2017**.
- The initial data pull of pre-identified students to eDIRECT will be on **March 10, 2017** after **5:00 PM**.

- Schools will have access to the pre-identified students to establish test sessions in eDIRECT on **March 17, 2017**.
- After the initial load of students into eDIRECT, any new or additional students must still be pre-identified on the Secure Site. Students will be copied into eDIRECT twice a day through the end of testing.
- Students can be pre-identified on the Secure Site using any of the following methods:
  - ♦ Pre-ID File Upload
  - ♦ MSDS Copy
  - ♦ One Student at a Time

## Test Session Creation

Pre-identified students will need to be put into online test sessions.

- Schools will **not** put students in test sessions on the Secure Site as done with other state assessments.
- Schools will need to place students into test sessions in eDIRECT starting on **March 17, 2017**, once the students have been transferred to eDIRECT. All students must be pre-identified in the Secure Site first in order to be transferred to eDIRECT and then placed into test sessions.

## Student Log-In

The pilot test will use the same INSIGHT software (and TSM back end) used by M-STEP and other statewide tests. If your computers are set up for M-STEP, they are already set up for the pilot test. Students will simply select the icon for pilot testing to log in.

## Important Note

The Science Pilot Assessment is an optional assessment, and is **in addition** to the required M-STEP science assessment in grades 4, 7, and 11. The Pilot Assessment **does not replace** the M-STEP science assessment. Please make sure this information is communicated to all assessment staff in the pilot-participating school.

### Michigan-Specific Manuals

Michigan-specific testing manuals are now posted on the [MME web page](http://www.michigan.gov/mme) (www.michigan.gov/mme). The implementation planning kit, scheduled to start shipping on February 15, will contain samples of printed manuals. The number in parentheses below indicates how many manuals to expect in the February shipment. More manuals will be shipped with the testing materials. See information below about an upcoming webinar on how to use the manuals and other administrative tips.

The PSAT 8/9 and PSAT 10 supervisor manuals will include information on preparing for test day, providing accommodations, testing scripts, and information about the set-up and return of materials. (10 for each assessment)

- There is a separate manual for administering the PSAT 8/9 and PSAT 10 using MP3 audio or Assistive-Technology Compatible (ATC). (1 for each assessment)
- The SAT manuals have been updated to provide specialized information to each type of test day staff.
- **Test Center Supervisor Manual** – includes information about the set-up and return of materials as well as administrative information such as preparing for test day. (2)
- **Testing Room Manual** – includes all test day scripts and information needed by associate supervisors. (10)
- **SSD Coordinator Manual** – includes expanded information on accommodations administration, test day scripts for testing students on the NAR including students testing with MP3 audio or ATC, and instructions for returning accommodated materials. (2)

### Online Attendance Rosters

This year, SAT test center supervisors will have access to the supervisor's online attendance roster (SOAR). The online attendance roster is a tool that is maintained by Educational Testing Service (ETS) and lists all students who will test under the supervision of the test

center supervisor. The online attendance roster is not available for PSAT. Similarly, the SSD coordinator will have access to the nonstandard administration report (NAR) that will list all of the students who will test under the supervision of the SSD coordinator. The NAR is available for both the SAT and PSAT-related assessments. In mid-February, the SAT test center supervisor will receive an email from ETS indicating that you are able to set up your account to access the online attendance roster. This is a separate account with ETS and is different than your College Board professional login.

**PLEASE NOTE:** Students will not be populated in the NAR or online attendance roster until March 24. More information about using rosters will be available in next week's Spotlight and in an upcoming webinar (see details on next page).

## Updates to the Online Learning System

We have made improvements to the platform in which the online test center supervisor training is delivered. The training will no longer take 24 hours to load as it did last year, supervisors should have immediate access. Additionally, the training is modularized so that users can complete the training in small segments, and visit specific segments (such as packaging test materials to return) as needed. A single link will be used to access the PSAT and SAT training. This training is available to help you through the big steps of an administration, but the

Supervisor's manual remains your gold source for all information. If you have any questions, always refer back to your manual.

## SAT Training

SAT test center supervisors are required to complete an online training one time, no later than two weeks prior to test day. If you completed the training last year, we highly encourage you to take the training again as it has been updated for this testing year. The online training modules for test center supervisors and SSD coordinators are the same; therefore if you hold both roles, you will only need to go through the course one time.

Training will be available **February 9, 2017**. SAT test center supervisors will receive an email with a link to access the training through the online learning system. The link can then be shared with other necessary test day staff.

Test center supervisors are responsible for training other test day staff. You can use the available online training that is specific for associate supervisors and provides information applicable to supervising a testing room. You can also provide training sessions at a staff meeting, for example.

You will need your 5-digit SAT test center number and 6-digit College Board assigned Attending Institution (AI) code to access the training. Please have these numbers available when logging in for the first time. If you don't know your AI code, you can **search for your high school** by name and zip code.

## PSAT Training

PSAT test center supervisors are required to read the testing manual and train test day staff. If interested, a webinar will be provided on **February 13, 2017 at 10:00 AM EST**. Go to [www.tinyurl.com/MichiganPSAT](http://www.tinyurl.com/MichiganPSAT) to register. If you are not able to attend, you can still register and a link to the presentation will be emailed to you following the webinar. In early March, a recording of the webinar will be available to review in the same learning management system as the SAT training.

If you are a supervisor supporting multiple assessments such as SAT and PSAT, you will need to request SAT and PSAT training courses in the LMS separately. Log back into the LMS in early March to get the recorded PSAT course assigned to your account. **Please note:** Training for PSAT 10 and PSAT 8/9 has been combined into a single course, there are not separate modules for these two assessments.

## Recently Asked Questions . . .

### **Why can't I enter the number of test booklets that I need to order for MI-Access Participation (P) and MI-Access Supported Independence (SI) on the Initial Material Order screen?**

Since the P and SI tests are given one-on-one, there is no need to order a set of testing materials for each student. You only need to identify the number of teachers who will be administering the test to the students and enter that count into the Administrator box. This will ensure that you get enough materials for each teacher administering the P and SI.

### **Where do I find out how and where to enter MI-Access Participation (P) and MI-Access Supported Independence (SI) scores?**

You will be able to find the instructions at [www.michigan.gov/mi-access](http://www.michigan.gov/mi-access) by clicking on the "P/SI Online Answer Document Instructions for Score Entry" document under the Current Assessment Administration section. This document is being revised and will be posted by the end of February.

### **What tests do students who are in grade 9 and 10 take if they are cognitively impaired or would have taken an alternate assessment if there was one available?**

Students in grades 9 and 10 who have, or function as if they have, a significant cognitive impairment and would otherwise take an alternate assessment are welcome to take the assessment. However, students who would otherwise take an alternate assessment are not required to take the PSAT 8/9 or PSAT 10.

### **I received WIDA ACCESS for ELLs 2.0 materials for a student that I don't believe is an English Learner. Is this student required to test?**

Unless this student has left your district, has received an approved WIDA Test Exception, or False LEP approval this student is expected to be assessed on the WIDA ACCESS for ELLs 2.0.
