M-STEP 3, 4, 6, and 7 Paper/Pencil Makeup Testing Ends Friday, May 19, 2017

All paper/pencil makeup testing for M-STEP grades 3, 4, 6, and 7 ends Friday **May 19, 2017**. Paper/pencil testers do not have the same testing window as online testers. Please refer to the [Paper/Pencil Summative Testing Schedule](#) on the [M-STEP web page](#) (www.michigan.gov/mstep) for allowable paper/pencil testing dates. Students being assessed online must complete all test session by **4:00 PM Friday, May 26, 2017**.

MI-Access Update

Testing Window Closing

The MI-Access testing window closes on **Friday, May 26, 2017 at 4:00 PM**. This will be the last day to administer any level of the MI-Access assessments and to enter all Supported Independence and Participation scores. Here are a few things to consider:

ONLINE – Functional Independence (FI):

- Schools with FI testers must clear the Testing Site Manager (TSM) at the end of the day on Friday May 26, 2017.

- All “In Progress” tests will be automatically closed and be sent for scoring.
- **Important:** Students taking FI ELA: Accessing Print (online or paper) must also complete the FI ELA: Expressing Ideas assessment which is exclusively a paper assessment.
- Students must take both part 1 and part 2 of each content area.

PAPER/PENCIL:

- All paper-based testing must be administered by the **Friday, May 26, 2017** window closing date.
- **Remember that FI ELA: Expressing Ideas is hand-scored and may be returned (using return instructions) early if they are all completed.** There is no need to wait until all online sessions are submitted.

PARTICIPATION AND SUPPORTED INDEPENDENCE (P/SI):

- ALL P/SI student scores must be entered online by **May 26, 2017 at 4:00 PM**.
- The link to the [P/SI score entry](#) may be accessed on the [MI-Access web page](#) (www.michigan.gov/mi-access) under the **Current Assessment Administration** section.
- Complete instructions for entering scores may be found at this link.

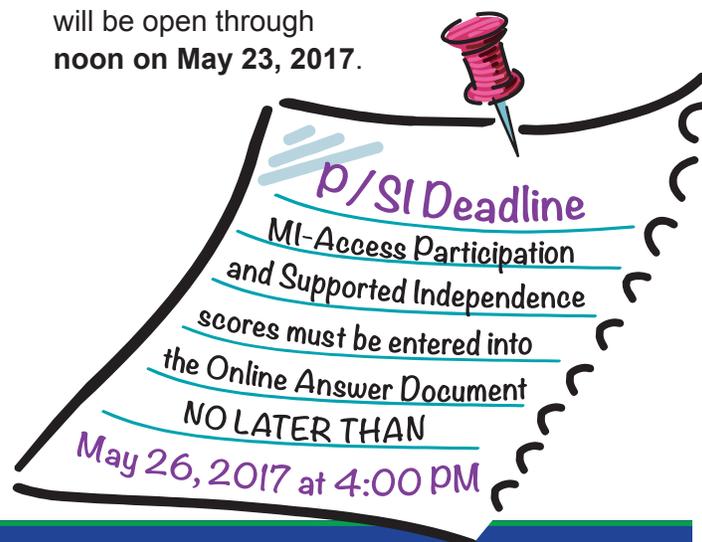
- All Scoring Documents and signed Security Agreements should remain in the district for three years.

Testing Material Return Date

- All paper testing materials (including all FI Expressing Ideas tests) must be shipped by **May 30, 2017** to avoid possible late fees. **Please note that this is earlier than in past years.**
- Complete return instructions are listed on pages 38-40 of the [Paper/Pencil Test Administration Manual](#) or the [Instructions for Materials Return](#) located on the **Current Assessment Administration** section of the [MI-Access web page](#) (www.michigan.gov/mi-access).
- Schools have been provided with return kits with their materials, thus helping to facilitate a direct return rather than going through your district office to return. This will also help meet the earlier return deadline as well. Please locate your return kit now in case you need to order an additional return kit before this deadline.

MI-Access Participation and Supported Independence Social Studies Assessment

All students in grades 5, 8, and 11 are expected to take a summative assessment for the social studies content area. Since there is not a MI-Access Participation (P) or Supported Independence (SI) level social studies assessment provided by the state, schools are expected to test P/SI level students with a locally developed/approved alternate social studies assessment. Local alternate social studies assessments can be common commercial social studies assessments or locally-developed instruments that include item types such as constructed response, multiple choice, performance tasks, rating scales, observation checklists, portfolios, or others. The administration of the locally developed/approved alternate social studies assessment should occur any time prior to the SAT/M-STEP/MI-Access Verification of Not Tested window, so that student participation can be recorded in the Secure Site.

In order for P/SI level students to be recorded as having met the social studies test participation expectation, schools will need to submit a “Local Alternate Social Studies” issue from the “Students Not Tested” report in the Secure Site. This can be done during the Verification of Not Tested window for the M-STEP/MI-Access/SAT that will be available in June. Submitting these issues will ensure that the school is credited for P/SI level students meeting the social studies test participation requirement. Instructions for the Spring 2017 Accountable Students and Test Verification windows and their associated dates are in the following article.

Please note: For **Shared Educational Entities (SEEs)** and **Specialized Shared Educational Entity (S2E2s)**, the district and school operating the SEE building or S2E2 classroom program must be the one

that both tests P/SI level students with a local alternate test and also manages all elements of the Accountable Students and Test Verification functions on behalf of the resident districts that participate and send students to the SEE/S2E2.

The dates noted in the following article are the last opportunity to verify data **BEFORE** assessment and accountability reporting!



Accountable Students and Test Verification Process - Spring 2017

Please review the following date windows in the Secure Site as listed below. These are the only and final opportunities to review, correct, appeal or submit issues related to Spring 2017 data for assessment and accountability reporting. No appeals or corrections will be accepted after these review windows.

Verification of Enrollment

The Verification of Enrollment list can be viewed now using the “Accountable Students & Test Verification” option from the **Student Assessments** section of the [Secure Site](https://baa.state.mi.us/BAASecure/Login.aspx) (<https://baa.state.mi.us/BAASecure/Login.aspx>) for grade K-12 English Learner (EL) students (WIDAACCESS for ELLs and WIDA Alternate ACCESS for ELLs) and all grades 3 – 8, 11 and required grade 12 students (M-STEP, SAT and MI-Access). When verifying the enrollment list you should use an “as of date” on or before as listed below. All students enrolled by the “as of date” should be listed. If they are not, a Student Record Maintenance (SRM) file with the correct student enrollment information should

be submitted in the Michigan Student Data System (MSDS). If a student exited the school prior to the “as of date” listed below, an SRM should be submitted with the student exit information in the MSDS. Student demographics should also be updated or corrected in the MSDS with an SRM. Please see the instructions for which demographics can be changed and those that cannot. The Verification of Enrollment and Demographics list will be updated from MSDS daily through the final pull using the dates below.

- **EL Students K–12:** “as of” March 24 and submitted in MSDS by **May 24, 2017**
- **All grade 3–8, 11 and required grade 12:** “as of” May 26, 2017 and submitted in MSDS by **June 22, 2017**

It is **IMPORTANT** to remember that any **SRM data corrections must be submitted and certified by 5:00 PM on the date posted above in the MSDS** using an “As of Date” on or before the posted date above, or the data will not be pulled for assessment and accountability reporting purposes. We will not be using the End-Of-Year Collection for this information. **Please communicate this with your district MSDS person (usually the district pupil accounting person).**

DEADLINE for submission of **Student Record Maintenance (SRM)** files in the Michigan Student Data System (MSDS) to update the Verification of Enrollment has changed from June 21 to **June 22, 2017 at 5:00 PM**

Verification of Answer Documents

The Verification of Answer Documents report includes students who tested online and paper/pencil. It is important to review to ensure all tests taken are listed. It is also important to verify other answer document information such as tests marked for prohibited behavior, nonstandard accommodations, etc.

Verification of Answer Documents will be available:

- **WIDA ACCESS and WIDA Alternate ACCESS for ELLs:** **Now - May 24, 2017 at 5:00 PM**
- **SAT, PSAT 8/9 (grade 9 only), PSAT 10, and WorkKeys:** **May 24 at 8:00 AM – May 31, 2017 at 5:00 PM**
- **M-STEP and MI-Access:** **June 15 at 8:00 AM – June 22, 2017 at 5:00 PM**

A few notes:

- **Missing Test** – a test was taken at the school, but is not listed as received for the student. Student has at least one content area test received but is missing at least one other test that is known to have been taken. A scanned image of the seating chart **MUST** be completed and attached to the missing test issue submitted.
- **Missing Student** – a student took one or more tests in your district, but is not listed on the page. Student was known to have tested and is missing from the Answer Documents Received report entirely. A scanned image of the seating chart **MUST** be completed and attached to the missing test issue submitted.
- **Move** – a student test record appears as received for a student who was known to have not tested at the school. Do not submit a Move issue for a student who tested at the school and then moved to another school during the testing window.

Verification of Students Not Tested

The Verification of Students Not Tested reports include students who were enrolled but not tested in one or more content areas. Schools will need to submit a reason that a student did not test in one or more required content areas for federal reporting and also for a possible accountability exception to the participation requirement. **This will be available for WIDA, SAT, M-STEP, and MI-Access only.** PSAT 8/9, PSAT 10, and WorkKeys will **NOT** be used for accountability calculations in Spring 2017 so schools will not need to submit a reason a student did not take one of these three tests.

The Verification of Not Tested will be available:

- **WIDA ACCESS and WIDA Alternate ACCESS for ELLs: Now – May 31, 2017 at 5:00 PM**
- **SAT, M-STEP, and MI-Access: June 15 at 8:00 AM – June 29, 2017 at 5:00 PM**

This document will walk you through the process, giving pointers on what to look for, how to report issues and how to fix an error when possible, along with helping to identify possible issues. A list of the various not tested reasons available for submission on the Students Not Tested report is also available in these instructions.

Answer Document Verification Window: May 24–31, 2017

The Michigan Department of Education (MDE) answer document verification process on the Secure Site provides a way for schools to verify that all answer documents have been received and processed by the College Board. It is also used to resolve other potential issues with answer documents. The deadline to review and report PSAT 8/9, PSAT 10, and/or SAT answer document issues through the Secure Site is **May 31, 2017**. Please see the [Verification of Answer Documents article](#) on page 4 for information on these processes.

Student Demographic Information

Please see the SAT and PSAT Student Demographics article on page 2 of the [May 11, 2017 Spotlight](#) (www.michigan.gov/mde-spotlight) for important information regarding the reporting of student demographic information. To ensure the

most accurate information in the K-12 reporting portal please complete this activity on the Verification of Enrollment screen on the Secure Site no later than **June 8, 2017 at 5:00 PM**.

Score Release

Students who participated on the initial test day(s) for SAT, PSAT 10, and PSAT 8/9 received access to their scores in their College Board account beginning on May 10, 2017. Please note that students who tested as part of the makeup test day may not have been included in this initial release of scores; the scores for these students will be released on a weekly basis as they become available. **Educators will have access to scores in the K-12 reporting portal by the end of June, after the completion of all answer document and enrollment verification-related activities in the Secure Site.**

Paper Score Reports and Accessing Scores

One copy of PSAT 8/9 and one copy of PSAT 10 paper score reports will be delivered to schools in July. SAT score reports are not delivered directly to schools. Educators can batch print copies of PSAT 8/9, PSAT 10, and SAT score reports from the K-12 reporting portal, as needed, once scores are released to educators.

Scores are available through a student's College Board account. If a student logs into their College Board account and does not see a place to access their SAT scores, they need to link their registration to their scores (especially if the student is creating an account for the first time).

Link Your Account to Your Registration: If your student's SAT School Day registration does not appear, students will need to link their account to their registration.

- a. Select **My SAT**.
- b. On the SAT Registration page, click **Continue** to get started.
- c. In the **Previous Registration** section, choose "Yes" and enter the registration number for your SAT School Day in the **Your Previous Registration Number** box.

You will need to provide the registration number to students. These can be found in the Roster Report of the K–12 Reporting Portal.

- d. Select April 2017 for the **Date You Took the Test**.
- e. Complete the **Personal Info** section using your full legal name that matches what your school has on file.
- f. Complete the **High School** section by entering your expected graduation date and grade level.
- g. Complete the **Mailing Address** section.
- h. Verify your email address is correct. Click **Save & Exit**.

There still may be cases where a student is unable to link the test registration and the College Board account because the information is too different. If a student still does not see the registration on the My SAT page, he/she can call the College Board's Student SAT Help Line at 1-866-756-7346.

Note: It may take up to 24 hours for the scores to load into the account once linked.
