Spring 2017 M-STEP Guide to Reports

The M-STEP Guide to Reports provides educators important information about scoring, the data contained in each report, the reports that are available in the Dynamic Score Reporting Site, and the functionality of each report.



M-STEP and MME Printed Parent Reports and Student Record Labels Are On the Way

Shipment of the M-STEP and MME Parent Reports and Student Record Labels has begun. Schools can anticipate the arrival of their students' Parent Reports and Student Record Labels before the first of September.

Parent Reports are to be distributed by the school to students' parents or guardians; Student Record Labels (labels are not provided for ACT WorkKeys) are intended to be used as labels for student records.

The Michigan Department of Education (MDE) has updated tools that can help schools and districts discuss and share their results from the 2017 Michigan Student Test of Educational Progress (M-STEP) and Michigan Merit Exam (MME).

IMPORTANT – While individual student results – such as Parent Reports – may be shared with parents at this time, it is NOT permissible to share any school-, district-, or state-level results with parents, the community, or other external parties until the embargo is lifted by the MDE. School Board meetings are considered open meetings; therefore, the sharing of embargoed assessment results at these meetings is not permissible until the embargo is lifted.

Please Note: MI-Access Parent Reports and Student Record Labels will be delivered later in September.

Spring 2017 M-STEP Aggregate Data File Now Available

The Office of Educational Assessment and Accountability (OEAA) is pleased to announce the availability of the downloadable Spring 2017 M-STEP Aggregate Data File. This data file is **embargoed** until the public release of Spring 2017 assessment results.

To download your school's aggregate data file, log-in to the [OEAA Secure Site](#) (www.michigan.gov/oeaa-secure) go to the **Report** menu, and select **Student Test Scores**.

IMPORTANT – While embargoed individual student results may be shared with parents at this time, it is **NOT** permissible to share any school-, district-, or state-level results with parents, the community, or other external parties until the embargo is lifted by the MDE. School Board meetings are considered open meetings; therefore, the sharing of embargoed assessment results at these meetings is not permissible until the embargo is lifted.

MDE's Early Literacy and Mathematics Benchmark Assessments – Online Only

The Michigan Department of Education's (MDE's) Early Literacy and Mathematics Benchmark Assessments will be available in Fall 2017 for students in Kindergarten, Grade 1, and Grade 2 from **September 11, 2017** through **October 6, 2017**. To prepare your students for the Online Assessments, teachers should provide the opportunity for students to view the student tutorial and practice the Online Tools Training (OTT).

Online Resources

The Office of Educational Assessment and Accountability (OEAA) has developed online resources for students taking state assessments at all grade levels. The resources support the idea that children can learn about online technology when teachers and other educators demonstrate the use of technology (classroom viewing of the student video tutorial, classroom viewing of the OTTs), followed by interacting with children while each student practices with technology (OTTS).

• Student Tutorials

The OEAA has created Student Tutorials. These are student-narrated videos that introduce teachers and students to the online tests and tools contained in the Early Literacy and Mathematics Benchmark Assessments. The Student Tutorials are designed to be administered in a group setting, such as the classroom, using a projector or other similar resource. The tutorials can be accessed three different ways:

- ♦ [eDIRECT](https://mi.drctdirect.com) (https://mi.drctdirect.com) — Select **All Applications** → **General Information** → **Test Tutorials**. Click on the icon under the **Action** column. This takes you to the tutorial page.

- ♦ **INSIGHT** — Open INSIGHT and on the bottom of the page select the **DRC INSIGHT Online Assessments Tutorials** link.
- ♦ [Chrome](https://wbte.drctdirect.com/MI/portals/mi) (https://wbte.drctdirect.com/MI/portals/mi) — You must use the Chrome browser to access the tutorials. Click the yellow link at the bottom of the page: **DRC INSIGHT Online Assessments Tutorials**. This is the same link used for the online sample item sets.

An important component of the Student Tutorials is that they provide explicit training on the pause/exit/end test functionality of the online testing engine. In addition, the tutorials explain how to access and use specific tools.

• Online Sample Item Sets and OTTs

Another important set of resources teachers can access are online Sample Item Sets for students in grades K–2. The Sample Item Sets are a select group of test items in ELA and mathematics that encompass various kinds of technology-enhanced items (drag and drop, hot spots, etc.) and are embedded within the OTTs. The sets provide teachers and students with practice in solving grade-level and content-specific test items aligned to Michigan's content standards, and provide practice navigating the online test delivery system. The OTTs can be accessed two ways:

- ♦ [Chrome](https://wbte.drctdirect.com/MI/portals/mi) (https://wbte.drctdirect.com/MI/portals/mi) — You must use the Chrome browser to access the OTTs. Choose the **Online Tools Training** link located under **K, 1, 2 Early Literacy and Mathematics** on the lower left side of the page.
- ♦ **INSIGHT** — Open INSIGHT and on the lower left side of the page, select the **Online Tools Training** link under **K, 1, 2 Early Literacy and Mathematics**.

Feedback collected from previous administrations indicates that students and teachers who utilized the OTTs Sample Item Sets felt more prepared for online testing, students reported feeling confident about taking assessments online, and school administrators and teachers stated they experienced fewer issues related to online testing than students and teachers who did not take advantage of this resource.

• Recommended Sequence

The OEAA recommends that classroom teachers introduce online testing to their students by playing the Student Tutorial Video in class to show students how the online testing system and tools work. Once the Student Tutorial video is shown and discussed in the classroom, teachers then show the Online Tools Training (OTTs) to the entire class (doesn't have to be on the same day). After students have watched the Student Tutorial Video projected by the teacher, followed by watching the teacher navigate through the OTTs via a projector or other classroom viewing resource, each student should be provided hands-on practice with the online Sample Item Sets contained within the OTTs, ideally using the device they will use during testing.

Managing Users on the Secure Site

District and School (public and nonpublic) Administrator level users of the Secure Site—have you checked who has access to your student and school data on the Secure Site lately?

The Secure Site is set up to allow districts and schools (public and nonpublic) to directly manage users access to their student and school data on the Secure Site.

Each district should have one or more District Administrator-level users set up on the Secure Site. It is up to the district superintendent to decide who the users will be by submitting a District Administrator-Level User form found on the login page of the [Secure Site](http://www.michigan.gov/oeaa-secure) (www.michigan.gov/oeaa-secure). This form must be completed by the superintendent and the designated user. It is the District Administrator-level user's responsibility to approve system requests for access to the Secure Site, create new users, manage the roles of the users and disable users when they no longer need access to the Secure Site, whether it is due to a change in job duties or they have left employment. The process is the same for Nonpublic School Administrators using the Nonpublic School Administrator-Level User form available on the login page of the Secure Site and completed by the nonpublic school principal or administrator and the designated user.

The district administrator-level user can authorize public school administrator-level user access and those users can also approve system requests for access to the Secure Site, create new users, manage the roles of the users and disable users when they no longer need access for the school(s) that they are assigned to.

As a district or school (public and nonpublic) administrator-level user, please take the time to review who has access, what level of access they have, and to disable those who no longer need access to the Secure Site. If a district administrator-level user or nonpublic school administrator-level user no longer needs this access for any reason, the district superintendent or nonpublic school principal or administrator will need to email baa@michigan.gov a request to have their account disabled or fax a letter on district or nonpublic school letterhead to 517-335-1186.

This also includes a list of the available roles and assessments, along with a description of each one.

Updating Entity and Contacts in the Educational Entity Master (EEM)

To assist schools with verifying the contact information in the Educational Entity Master (EEM), a District and School Contact screen is available on the [OEAA Secure Site](#) (www.michigan.gov/oeaa-secure). Once logged on to the Secure Site, go to **District and School Contact** under the **Assessment Registration** menu. The screen will pull contacts used by the OEAA and display them in an easy-to-read format for any user of the Secure Site to view. If you notice an error with the contact name, phone number, or email address, please work with your authorized district EEM user (usually but not always the student pupil accounting person) to have the EEM updated. The information is updated nightly from the EEM, so you will not see changes until the next day.

Please note that even though the coordinators' addresses are not displayed on the District and School Contacts page of the Secure Site, it is important to make sure the contact type addresses are correct in the [EEM](#) (www.michigan.gov/eem) along with the grade levels serviced. The address and grade levels serviced are used for ordering materials and delivery of materials and reports.

information for the district—listed on the District and School Contact page in the Secure Site. This will assist schools with getting updated information to the District EEM and MSDS authorized users. **Note:** The EEM and MSDS authorized users are not pulled from the EEM but are pulled from the Center for Educational performance and Information (CEPI).

NOTE: Although more than one coordinator can be entered into the EEM, only the most **recent** entry will be used for assessment and accountability purposes.

WIDA W-APT Grades 1–12 Discontinuation

As a reminder, educators should now be using the new **WIDA Screener Online** instead of the WIDA ACCESS Placement Test (W-APT) to assess incoming students in grades 1-12 who may be English Learners (ELs). All materials and training modules for the grades 1-12 W-APT will be removed from the wida.us website and secure portal on August 31, 2017.

Please note that assessment materials and training modules for the **Kindergarten W-APT** will remain on the wida.us website and secure portal. Michigan is continuing to use the Kindergarten W-APT for screening incoming Kindergartners.

Inaccurate Co:Writer Announcement

Educators may have recently received direct communication from a software company that

indicated students now had the ability to use a non-embedded accommodation called Co:Writer on the M-STEP assessments. The Office of Educational Assessment and Accountability (OEAA) asks that educators ignore this announcement from Don Johnston, Inc. at this time. The OEAA is currently working with DRC to investigate the compatibility of third-party software with INSIGHT. A final decision on the availability and use of this program for M-STEP has **NOT** been determined. Please wait for more information directly from the MDE on this topic in coming months. If you have a student who regularly uses technological supports in the classroom, and whose IEP or section 504 plan requires its use on assessments, please make an individual accommodation request to the OEAA.



Fall and Spring Assessments

Like last year, schools do NOT need to order materials for the primary date of the Michigan-provided SAT, PSAT 10, and PSAT 8/9 assessments in Spring 2018 through the College Board's test ordering system. If you elect to participate in fall testing of PSAT/NMSQT or PSAT 8/9, materials should be ordered directly through College Board. Fall testing of PSAT/NMSQT or PSAT 8/9 is not provided by the Michigan Department of Education.

National SAT Administrations for Students with Certain Disabilities

The majority of students who sign up to take a national weekend administration of the SAT will take the test at the test center in which they register. However, for students who require certain accommodations—which include 100% extended time testing over two days, MP3 Audio, Assistive Technology (ATC), braille, or large font needs greater than 20 point—the opportunity is offered to test in their school due to their special testing needs. This means your school, even if you have not signed up to be a national test center, may

have students looking to test at your location. The decision to support this administration is completely at the discretion of the school. Neither the College Board nor the Michigan Department of Education requires you to participate nor does this have an impact on the state-provided spring testing. To see the students at your school who have been approved for the accommodations noted above, as well as any administrations for which those students have registered, your school's SSD (Services for Students with Disabilities) Coordinator can log in to the SSD Online system. If you decide to not support the national testing for these students, College Board will work with students directly to find another school in the area that is available. ACT began reshipping the package(s) on Monday, August 21, 2017. If your school was closed for the summer, the package(s) will be shipped to the original mailing address. If your school is permanently closed, the package(s) will be shipped to the district mailing address. If there is an instance where the district is closed, those certificates will be shipped back to the Michigan Department of Education.
