SUBJECT: State Aid Supplemental Legislation, Public Act 11 of 2019 (House Bill

4206 of 2019)

The Governor recently signed House Bill 4206 into law with immediate effect as PA 11 of 2019. Effective for the 2018-19 school year only, this law amends Section 101(4) of the State School Aid Act (MCL 388.1701), allowing districts to have canceled instructional time forgiven if instruction was scheduled but not provided on 1 or more days included in the period, January 29, 2019 through February 2, 2019, for which the governor issued an executive order declaring a state of emergency across this state. Any day that is forgiven under this language will also have the subsequent number of instructional hours originally scheduled for that day forgiven.

In order to use this flexibility, the following criteria must be satisfied:

- The day being forgiven must be a day where instruction was originally scheduled.
- The day being forgiven must have occurred between January 29 and February 2.
 - February 2, 2019 can be forgiven if instruction was scheduled for that Saturday.
- The district has requested forgiveness from the Department using the online form.
 - If the district already applied for forgiveness this year, a second request is not required even if the original request was not granted.
