Technical Assistance and Professional Development

In response to the feedback provided by MDE in the spring of 2018, Wayne RESA continued to provide support to the local member districts and PSAs in various capacities. In September, a Wayne RESA consultant presented to the countywide PAC assembly the current legislation and the parent's role in the appropriate assessment decision-making as a member of their child's IEP team. In addition, RESA distributed and discussed with members the MDE "Should My Student Take the Alternate Assessment?" flowchart. Also in September a Wayne RESA consultant presented the spring 2018 feedback from MDE as it relates to the 1% Justification Cap to all membership districts and PSAs. RESA conducted additional follow up with individual districts about the feedback by phone, or face to face with membership districts and PSAs, as needed or requested. Wayne RESA consultants continue to provide ongoing updates on current legislation and best practices regarding Alternative Assessment decision-making to Special Education directors and supervisors across Wayne County. At Wayne RESA, we provide ongoing consultation, technical assistance, or training as needed or requested to the membership districts and PSAs (by phone and in person) about assessment decisions by IEP teams. Once Wayne RESA consultants received the data from MDE, the assigned consultants provided the administration of each membership district and PSA with detailed information, tools and technical assistance on how to analyze the data, use the information gathered and make informed decisions and plans, and develop processes to support IEP teams within their districts in determining the appropriate assessment for each student.

From the positive feedback and ongoing requests from the Wayne County constituents, Wayne RESA will continue to provide the following trainings either on-site at RESA or in the membership district or PSA. The trainings are as follows:

- Specialized Instruction
- Personal Curriculums
- IEP Process as it relates to Alternate Assessment
- Technical supports on data as it relates to Alternative Assessment per district. In 2019-20, additional trainings will be developed to address membership district needs and requests.
- Effective implementation of Essential Elements
- In 19-20, a training will be developed to address a new request: Supports for English Language Learner students that have IEPs and the issues around determining the best
- Wayne RESA will continue to highlight the availability of training materials and online modules developed by MDE
