RESOLUTION

Jeremy Michael Hughes

WHEREAS, Jeremy M. Hughes received his Bachelor's degree in Philosophy and Latin, with minors in English and History from the University of Dayton in Dayton, Ohio; and

WHEREAS, Dr. Hughes received his Master's degree in Educational Administration and his Ph.D. in Educational Administration, with minor in Curriculum and Instruction from the University of Minnesota in Minneapolis, Minnesota; and

WHEREAS, prior to joining the Michigan Department of Education in October 2002, Dr. Hughes was director of the Office of Educational Assessment and Michigan Merit Award for the Michigan Department of Treasury for seven months (April-October 2002), superintendent of Dearborn Public schools for 13 years (1989-2002), superintendent of Haslett Public Schools for 10 years (1979-1989), assistant superintendent for curriculum and instruction for Saginaw Township schools for five years (1974-1979), a high school principal in Minneapolis, and a teacher of Latin and English in Ohio and Minnesota high schools; and

WHEREAS, Dr. Hughes joined the Michigan Department of Education in October 2002 as Deputy Superintendent/Chief Academic Officer; and

WHEREAS, Dr. Hughes served as Interim Superintendent of Public Instruction from March 10, 2005-July 3, 2005; and

WHEREAS, while serving as Deputy Superintendent/Chief Academic Officer Dr. Hughes worked with local school districts and the U. S. Department of Education to fully explain and implement the No Child Left Behind Act (NCLB) in a manner that would benefit all; and

WHEREAS, to further implement NCLB, Dr. Hughes shepherded many activities and projects including development of the Grade Level Content Expectations, recommendations regarding rigorous high school graduation requirements, the Michigan Merit Examination, the MI-Access examinations for students with disabilities, and JUST recently coordinated the activities of the Teacher Preparation Policy Study Group; now therefore be it

RESOLVED, That the Michigan State Board of Education receive with deep regret the news of the well-deserved retirement of this able and distinguished educator, and be it further

RESOLVED, That the Michigan State Board of Education extend to Jeremy Hughes its highest regard and heartfelt gratitude for the dedication and expertise he has brought to the children of Michigan, their parents, and the millions of Michigan citizens his work has affected and benefited; and be it finally
