ANSWER:

a. We purchased a wide variety of items that can be check out by patrons. Some items can be checked out individually while others were grouped together to form kits to be checked out. Some individual items purchased include: a paper shredder, snowshoes, laser tag, a telescope, a borescope, and metal detectors.

Each of the kits have individual themes such as mindfulness, birdwatching, learning first aid, senior fitness, microscopes, and travel games.

With these items we've created a 'Library of Things'. The goal of this is to expand services offered by the library and reach different demographics in our community.

b. With grant funding we were able to create 32 different kits or items that patrons can check out. Most of these were individual items although we did purchase multiple sets for laser tag, metal detectors, yoga, and snowshoes.

c. The audience varies greatly by kit. Some such as travel games, cooking kits, telescopes, would appeal to families or patrons of any age. Others are geared towards adults such as the home improvement/drill kit and the paper shredder. Generally, we tried to think of items that someone would need but not so often that they want to purchase their own. Or items one would need to start a new hobby, with this they can give it a try without the financial burden. While kits are geared for different ages, one must be 18 in order to check out a kit. This was done for liability reasons. We did include two 'in-house' kits which are available to patrons nine and up. One kit has the supplies to make friendship bracelets, the other includes duct tape projects.

d. We've used items from the Library of Things with programing; particularly STEAM programs and events. Items are showcased during special events for example, in March we will have indoor birdwatching. Birds will be hidden around the library and families can search for them. During this time, we will highlight our birdwatching kit.

a. We've received great feedback since we launched the project. Many people have expressed surprise and delight that we have these kits available. As we hoped a wide variety of people have checked things out. From older adults to young people. Many people comment that after checking out a kit they are now more interested in what other kits are available.

The Library of Things was launched on August 23rd as of October 18th a total of 27 items have circulated, some multiple times. Check out length can vary from one to three weeks.

b. We gave out a total of 27 surveys, a total of 14 were returned. Each returned survey was fully completed.
