**SUBJECT:** 2006-2007 Title II, Part D of the No Child Left Behind Act of 2001, Enhancing Education Through Technology (Ed Tech) Grant

The Department of Education is pleased to announce the 2006-2007 Title II, Part D, Enhancing Education Through Technology Grant Program. Approximately \$4,100,000 will be made available for the four grant categories in the 2006-2007 grant cycle. The detailed grant announcement can be found <http://www.michigan.gov/mde-grants> under the "What's New" section. This is a competitive grant program and will consist of four grant categories:

Category I - School and Classroom Formative and Summative Assessment Enhanced Through the Use of Technology

Category II - E-learning and Virtual School Initiatives Grant Program (continuation grant only)

Category III - Comprehensive K-12 Data Management and Student Data Tracking System (continuation grant only)

Category IV – Assisting Writing Instruction Through the Use of Technology

Grant applications must be submitted through the Michigan Electronic Grant System (MEGS) at <http://megs.mde.state.mi.us/megs/login.asp>, beginning October 20, 2006. A separate application must be submitted for each project proposed. Category I and IV, grant applications must be submitted no later than **11:59 p.m., November 20, 2006**. Category II was due September 28, 2006. Category III will be due at a later date.
