2018 PCMH Initiative Intent to Continue Participation

The SIM PCMH Initiative released an Intent to Continue Participation (ITP) on September 13, 2017. The ITP is aimed at understanding participants' intent to continue participation in the 2018 SIM PCMH Initiative and capture any personnel and/or infrastructure changes with regard to the SIM PCMH Initiative. Dashboard Release 2.0

Release 2.0 of the SIM PCMH Dashboard is targeted for the end of October. It will include the following:

Data

- Reporting period of 6/2016 – 5/2017
- May 2017 attribution
- Measure results calculated using Medicaid eligibility, medical and drug claims

New Measures

- Adolescent Well-Care Visits
- Childhood Immunization Status
- Chlamydia Screening
- Immunization Status for Adolescents
- Lead Screening in Children
- Well-Child Visits in First 15 Months of Life
- Well-Child Visits in Third, Fourth, Fifth, and Sixth Years of Life

New Functionality

- Users can view data at the provider level
- Users can compare data between Managing Organizations, Practices, and Providers (based on access rights)

PCMH Patient Lists (PPLs)

Starting this month, the PPLs are being enhanced to include chronic condition and utilization information for patients. More information will be included in the announcement email when we post the September PPLs (targeted for 9/27).

HEDIS 2018

Measures on the SIM PCMH Dashboard will be transitioned to [HEDIS 2018](#) for Dashboard Release 3.0, which is currently targeted for a January 2018 release. We will provide more information about this change in the coming months.
