Upcoming Michigan Data Collaborative Deliverables

CHIR Dashboard

Michigan Data Collaborative plans to release the CHIR Dashboard in late February. This Dashboard contains the same data that is available in the SIM PCMH Dashboard, but is limited to only the participating organizations that are included in a CHIR, and it is aggregated to the CHIR level only. There is no reporting at the Managing Organization or Practice level.

New Reports Coming Soon

Michigan Data Collaborative is developing the following two new reports:

- Provider Report Michigan Data Collaborative is providing this monthly report to help organizations confirm provider assignments. It will reflect the Provider association to Managing Organizations and Practices.
- Care Coordination Claims Detail Report Because several organizations have requested more
 information about the underlying claims used to generate the Care Coordination reports, Michigan
 Data Collaborative is developing a report that will provide claims detail on the *Percent of Patients*Receiving Care Management Services. Michigan Data Collaborative will provide more details about
 this report in the coming weeks.

Dashboard Training

Michigan Data Collaborative is in the process of creating online training tutorials to help users set up, access, and use the Dashboards. We anticipate posting the first tutorial in early to mid-March. More details to come soon!

SIM Statewide Evaluation

Michigan Public Health Institute (MPHI) is overseeing the statewide evaluation of SIM, including the PCMH initiative. The two main areas of the PCMH evaluation will include embedded care management/care coordination and activities that address the Social Determinants of Health (SDoH). To minimize the reporting burden, MPHI will leverage existing monitoring data collected by MDHHS in its evaluation. Additional activities will include brief surveys on patient experiences with care management and SDoH screening and analyses of Medicaid Claims data for participating PCMH clients and a comparison group of non-participating PCMH clients. MPHI is currently working with University of Michigan and MDHHS to assess the need for a survey of care manager/care coordinator's experiences.

On April 10, MPHI will host an Office Hours webinar to discuss in further detail these evaluation plans and to get your input on what data elements you would find helpful in surveys, claims data analyses, and resulting reports. You can <u>register here</u>.

2018 Practice Transformation Collaborative

The PCMH Initiative has been working with partners at the Institute for Healthcare Improvement to further develop the 2018 Practice Transformation Collaborative. This learning network will continue as a focused opportunity for a cohort of PCMH Initiative Participants to engage in concentrative efforts to further refine and implement Clinical-Community Linkages. As a part of the collaborative design, there will be an opportunity for all PCMH Initiative participants to learn from the 2018 Practice Transformation Collaborative participants through virtual meetings. 2017 Quarter 4 SIM PCMH Initiative Payments

Participating payers will be processing the 2017 Quarter 4 Per Member Per Month payments for Practice Transformation and Care Coordination in the early weeks of March. Each participant key contact will receive a message with the summary of the payments they should expect to receive by participating payer including any manual adjustments to payment due to retroactive provider changes, or other necessary corrections. As a reminder, the Michigan Data Collaborative has posted the 4th Quarter 2017 Aggregated Patient Reports to further support participants in reconciling payments. Medicaid Health Plans are expected to make payments to participants by March 13, 2018.

Self-Management Training Options in 2018

To provide additional flexibility and convenience for SIM PCMH Initiative participants, three organizations will be available for self-management training for Care Managers and Coordinators who have not been trained previously:

- Integrated Health partners (IHP)
- Michigan Center for Clinical Systems Improvement (MiCCSI)
- Practice Transformation Institute (PTI)

Trainees must attest that they have not been previously been trained in self-management. Those who completed self-management training with a MiCMRC-approved vendor with MiPCT or another initiative do not need to be retrained.

If self-management training is completed through one of these vendors, the PCMH Initiative will cover the cost of the course. (Travel and any other related expenses are the responsibility of the attendee or their organization.) Note that the PCMH Initiative is able to cover a specific number of training slots with each self-management training provider (MiCCSI, PTI, and IHP). As those slots are filled we are able to reassess the capacity and funding in order to provide additional spaces. There may be times when the self-management training provider places registrants on a waiting list while the PCMH Initiative evaluates the ability to secure more funding for those spots. If the Initiative is not able to open more spots with a specific training provider, participants are encouraged to check out the availability with other training providers, or have the option to cover the course costs themselves.
