# Program News and Updates PCMH Initiative Quarter 3 Progress Report

The PCMH Initiative Quarter 3 Progress Report was released on September 26 and the submission deadline is Wednesday, October 31 by 5:00pm. The link to the electronic submission was distributed to your organization's key contact. You can preview the requirements and instructions to complete the report in the report guide. There is a "care manager lead" section in the "contact" spreadsheet, which will support care coordination collaborative connections at the practice level. Please provide only the care manager lead information rather than a comprehensive care manager list in this section.

## PCMH Initiative Intent to Continue Participation

As we approach January 2019, Michigan Department of Health and Human Services (MDHHS) is preparing for year three of the PCMH Initiative. Similar to the 2017-2018 transition, we will be hosting a webinar to inform all participants on how to indicate their intent to continue participation, as well as what programmatic changes and funding updates can be expected. We look forward to sharing this information with you on the second half of the next Quarterly Update webinar on October 4<sup>th</sup> from 12:00—1:30PM. #### **Evaluation Updates**

The PCMH Initiative provider survey is now closed and we received nearly 500 responses. Thank you for supporting this survey! We are in the process of analyzing the data and will have aggregate reports to you by mid-October. We are excited to announce that 14 provider organizations were approved to participate in the Clinical-Community Linkages (CCL) Data Partnership. We're looking forward to leveraging their data to assess changes in Medicaid costs and utilization related to patients' participation in CCLs. Finally, the Patient Experience Survey will be administered this Fall. Preliminary feedback on the survey was received from provider organization leads at the end of August. ### Social Determinants of Health (SDoH) Screening Tool: Updates Required for 2018

A quick reminder to all participating organizations that the addition of questions to the SDoH screening tool on personal/environmental safety (e.g. domestic violence) and family care (e.g. children, elders) is expected by November 2018. #### Upcoming Michigan Data Collaborative Deliverables

## **Care Coordination Report Reprocessing**

In mid-to-late December Michigan Data Collaborative (MDC) plans to reprocess the Care Coordination Reports to "true-up" previously-released reports. We will make the following updates:

- To include additional claims received by MDC after the original quarterly reports were generated, we will re-run the 4Q17, 1Q18, and 2Q18 Percentage of Patients with a Care Management Claim reports. There are several reasons that MDC receives claims after the original reporting period, including:
  - Some Medicaid health plans made improvements in processing the care management codes, and these claims were received after the reports were generated.
  - Some SIM PCMH participating organizations needed to make changes to their billing groups to include zero-dollar claims.
  - The regular adjudication process results in a lag between when claims are serviced and paid. This
    process allows for additional months of run-out claims to be included.
- MDC is also modifying the PCP Follow-Up After Inpatient Discharge reports to align with recent changes to the Acute Admissions measures on the Dashboard. These reports will also be re-processed in the revised logic.

#### SIM PCMH Dashboard Release 6.0

MDC plans to post Release 6.0 at the end of October. It will include the following:

- Paid claims through August 2018 (Medicaid data received by September 15, 2018)
- A 12-month reporting period of July 2017 June 2018
- June 2018 filtered SIM Participant File (SPF) and Provider Hierarchy data
- New measures, including Total Cost PMPM, Ambulatory Care Sensitive Condition (ACSC) Admissions, and multiple Quality Outcome measures

We will provide more information, including measure details, as we get closer to the release date.

#### Michigan Physician Orders for Scope of Treatment (MI-POST) - Educational Opportunities

According to the <u>www.acpmich.org</u> website, "Public Act 154 was signed by Michigan's Governor in November 2017. This law establishes the use of Physician Orders for Scope of Treatment in Michigan."

## **MI-POST**

A medical order designed to improve end-of-life care by converting patients' treatment decisions into medical orders that are transferable throughout the healthcare system. It is:

- A standard of care for communicating the scope of treatment decisions
- For frail elders or others whose death in the next 12 months would not be surprising.
- Always voluntary
- A form that follows the patient

MI-POST Goals:

- To create a specific written plan to document medical treatment decisions and ensure they are honored by healthcare providers throughout the continuum of care.
- Ensure discussions are focused on assisting the individual, or the designated Patient Representative, in making the following healthcare decisions:
  - o CPR
  - o goals of care for cardiopulmonary failure, including hospitalization
  - o artificial nutrition and hydration
  - o comfort care options
  - o other types of treatment desired

#### **MI-POST** and Advance Directives:

MI-POST and Advance Directives serve different purposes. According to the newly established law, an appropriately executed MI-POST form, as a medical order, takes precedence over the hypothetical advance directive document when it comes to medical treatment decisions. The purpose of an advance directive is to:

- Name a Patient Advocate, to communicate the individual's treatment decisions in the event he/she cannot. This is the legal portion of the document, called the Designation of Patient Advocate form.
- Communicate to the Patient Advocate wishes for future healthcare and other related wishes, in a nonlegally binding portion referred to as a living will portion.
- Ensure the Patient Advocate, as a legal decision-maker, can communicate medical decisions that result in the completion of a MI-POST or changes to an existing MI-POST.

The MDHHS is currently working with an advisory committee to finalize the MI-POST form and recommended rules to its use. The form is not yet readily available across the state.



#### Facilitators and Barriers to Care Coordination

The PCMH Initiative is committed to providing timely, applicable and relevant resources to our participants. As part of this commitment, we aim to share articles and tools that are newly published as well as some seminal pieces in the national literature that capture learning and are cornerstones that have stood the test of time. This month, we focus on an interesting contribution from University of Delaware researchers published in *The Journal of the American Board of Family Medicine* in 2016, "Facilitators and Barriers to Care Coordination in Patient-Centered Medical Homes (PCMHs) from Care Coordinators' Perspectives".

The authors studied a group of care coordinator and managers from various states. The most common elements of their work were: Reaching out to patients, conducting face to face patient encounters, providing social support to patients, collecting, managing and exchanging patient data, supporting physicians and backing up other practice staff. Their caseloads ranged from 200 to 500 patients.

The article identifies several techniques to overcome challenges and increase potential for success:

- Separating responsibility for care coordination/management from panel (population) management;
- Having some kind of system in place (even if simplistic) for gathering information about community resources and social agencies;
- Participating in regular team huddles;
- Taking time to "win over" or deliberately focus on good relationships with physicians and external facilities;
- Maintaining and improving skills in motivational interviewing (some starting informal "motivational interviewing clubs". One idea was to meet monthly in-person or via phone to practice role playing with difficult patients;
- Practicing self-care (e.g., yoga, meditation, etc.) to relieve stress and increase resiliency.

Take time today to consider whether one of these ideas is useful for your practice and organization, and what you have found to be most helpful in your work.
