# You can help promote and build awareness of Michigan's Safe Delivery of Newborns law

#### **Issue:**

Although there have been many newborns surrendered since the Safe Delivery of Newborns law went into effect in 2001, there are continued media reports of infants who are abandoned. Public and professional awareness remains a critical issue. Community agencies and individual volunteers can play a vitally important role in keeping the Safe Delivery message current in their agency, school, community, or region.

#### **Individual Actions:**

- Check local hospitals, fire departments and police stations for signs designating the building as a Safe Delivery site. Visit <u>Michigan.gov/SafeDelivery</u> for more information.
- Check with EMS agencies and/or 9-1-1 dispatch services to determine if they are prepared for a surrender. Visit <u>Michigan.gov/SafeDelivery</u> for more information.
- Distribute Safe Delivery resource materials. Posters, pamphlets, and brochures can be displayed/distributed at local businesses, health clinics, coffee shops, laundromats, runaway shelters, churches, malls, counseling centers, etc.

## Promoting Community Outreach and Advocacy

#### **Group Actions:**

Many of the individual activities can also be done as a group.

- Choose Safe Delivery as a community service project and do a variety of awareness events/activities.
- Set up a display table at a community event, such as a health fair.
- Survey local emergency service providers (hospitals, police, sheriff, and fire departments, or EMS and paramedics) on their awareness of and participation in professional and public promotion of Safe Delivery of Newborns.

#### How to Engage Community Partners:

- Build personal and/or group knowledge of the topic.
- Identify resources.
- Identify allies that may already be active or might have an interest.

#### Purpose:

- Promoting and raising community awareness of the Safe Delivery of Newborns law.
- Developing a strong community base for ongoing efforts to raise awareness.
- Distributing free resources to partners to circulate or display.
- Ensuring mandated ESPs are knowledgeable about their roles and responsibilities.
- Create an ongoing process to sustain public and professional awareness.
