Welcome and Introductions

Debi Cain convened the July 26, 2017 Sexual Assault Evidence Kit Tracking and Reporting Commission at the South Grand Building, 333 South Grand Avenue, Lansing, Michigan 48933 at 1:38 p.m. Introductions were made and a welcome extended to guests.

Reports

J. Nye from the Michigan State Police Forensic Science Division reported on the status of the Request for Proposal (RFP) for a statewide electronic tracking system. A Joint Evaluation Committee was formed in May 2017 and the request for proposal was published in June 2017. Bids on proposals were received by June 28, 2017 and are currently being reviewed. The evaluation process should be completed within the next two weeks allowing a recommendation to be made to the Department of Technology, Management & Budget (DTMB).

L. Rogers, Board Staff to the Commission, reported on the work of the Committee on storage of unreleased Sexual Assault Evidence Kits. A draft survey is being worked on that will eventually be sent to healthcare and sexual assault care providers to determine their options for storage.

M. Morrow, Bureau of Justice Assistance - Sexual Assault Kit Initiative (BJA SAKI) Project Director at the Prosecutor Attorneys Association of Michigan (PAAM) reported on the status of the auditing and testing of unsubmitted Sexual Assault Evidence Kits. There have been 2,444 kits inventoried statewide excluding 529 kits from Detroit and Flint. So far 1,661 kits have been tested which identified 452 Combined DNA Index System (CODIS) eligible profiles resulting in 246 CODIS hits.

Colonel Etue, Michigan State Police Director, reported on the emerging trends from 2016 crime data reporting on sexual assault. The data shows the percentage of rapes is up with the highest number of rapes occurring in June and July. The number of rapes reported to law enforcement was 6,571 victims in all age ranges. K. Worthy questioned the statistical accuracy of the 585 rapes reported in Detroit for 2016.

New Business

A workgroup was created to plan for recommendations on appropriations needed to begin the SAEK electronic tracking system. A second workgroup was created to identify legislative initiatives to implement recommendations and to address other related issues.
