

On March 17, 2015, the Bureau of Children and Adult Licensing completed Special Investigation #2015D0916016 and recommended revocation of the child care center license of Alphabet Soup Children's Center, Inc.

In settlement of all issues raised in Special Investigation #2015D0916016, the undersigned parties hereby agree:

- 1) Alphabet Soup Children's Center, Inc. neither admits nor denies that the specific allegations set forth in Special Investigation #2015D0916016 are true, but agrees that at least one violation of the Child Care Organizations Act, 1973 PA 116, has occurred.
- 2) Alphabet Soup Children's Center, Inc. understands that their child care center license to operate Little Cupcakes will be revoked, effective the date of signature by the representative of the Bureau of Children and Adult Licensing.
- 3) Alphabet Soup Children's Center, Inc. understands that an administrative hearing will not be held in this matter.
- 4) Alphabet Soup Children's Center, Inc. agrees not to apply for a license or certificate of registration for a Child Care Organization licensed or registered under the Child Care Organization Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.
