Consolidated Quals and BH Code Chart 20210423	Kasi/Jeremy	The version dated 20210423 is the most recent. Milliman still working on updating the document. The H2011 crisis code was inadvertently left off the MH-DD sheet, 15-minute crisis services are not limited to children.  Questions or comments submitted after the 4/26 meeting:  • Suggestion to establish an EDIT subgroup to review and update "Reporting and Costing Considerations" (Column K). The content in this column was created over many years by the EDIT group and is due for review.  • What codes can be used other than H0031 for an Autism assessment? Draft SFY 2022 Code Sets 20210423 document	Jackie/Jeremy  Kasi/Jackie	<ul> <li>Jeremy said that the document is still being updated by Milliman. Questions or comments submitted after the 4/26 meeting:</li> <li>What is the value for reporting education level modifiers on ACT codes? So that the state can see who is providing the services. Anne W. pointed out that this will add complexity to the billing. Kasi will ask Brenda Stoneburner if billing the highest credential would satisfy the need for who is providing the service. The SFY 2022 Code Set workbook, sheet named Final 2022 List includes H0039 with no modifier and with Y4 (SAMHSA approved EBP for Co-occurring disorders). Y4 is the only expected modifier to impact the rate, not provider credential.</li> <li>It was recently learned that the SFY 2022 Code Sets 20210423 will need some updates related to MAT services. Buprenorphine and naltrexone medications are moving to FFS.</li> <li>Still need MDHHS review the waiver language and service definition language in the Medicaid Manual for the WZ modifier. Skill building is not specifically included in the national H2014 definition. MDHHS will likely land on using WZ instead of HK for the HAB enrollees, but not using H2014 instead of H2015 for daytime activities.</li> <li>QJ (incarceration) modifier will remain in use, no change.</li> <li>When modifiers are included on encounters, the order doesn't matter.</li> <li>HF will be removed from the codes sets document, proposed modifiers sheet.</li> </ul>
Non-standard modifiers CHAMPS process	Kasi/Jackie	See column C (National Modifier) on Proposed Modifiers sheet. Jeremy said that Milliman already has a process for having these pulled from the MDHHS data warehouse erroneous table to be included in the monthly extract.
Milliman analysis of QJ Modifier	Jeremy	Analysis results showed nearly half of the QJ modifier services did not have an incarceration span (INCAR Benefit Plan assigned in CHAMPS).  Does the group think there is a need for CMHSP review of examples? Input from group is that about half sounds right, and no interest expressed in investigation.
