Unbundling Transportation	Kathy	Based on feedback from EDIT, it was decided to postpone this change from FY22 to FY23. In the Standard Cost Allocation (SCA) workgroup it was mentioned that some CMHs may want to move forward to make the change starting 10/1/21. Suggestion for BHDDA to communicate decisions via memo to the field.
TS modifier use on treatment plan monitoring services to continue	Jessica/ Milliman	At the last meeting we discussed the possibility of a new code for treatment plan monitoring (instead of using the TS modifier). The SCA Workgroup recommended to retain the TS modifier for H0032 and H2000. This is separate and distinct. Milliman reviewed HCPCS codes and did not identify anything that was similar. Propose to build independent rate models separately for H0032, H2000, H0032 TS, and H2000 TS.

Revised SFY 2022 Code Sets	Jeremy/ Milliman	<p>Latest version to be provided, may still be a few outstanding items.</p> <p>Jeremy reviewed a summary of changes to the workbook, both additions and deletions.</p> <p>The SFY 2022 Code Sets workbook will be shared.</p> <p>Outstanding items: HS modifier to indicate beneficiary not present, H2014 codes for waiver and non-waiver services, are group modifiers needed for T2015 (Out of home pre-vocational provided only 1-1?). Pam to check on 2015 and email the group. Email stated that T2015TT is set up in their EMR but has not be reported so far this FY. Anne W. pointed out some updates to the BHDDA Code Chart that need to carry over to the Code Set. Jeremy reviewed codes that might have up to four modifiers reported (sheet=2022 Services with 4 Modifiers).</p>
New labeling/naming of the H2014 for waiver services to distinguish from non-Waiver services. Currently H2014 without a modifier is non-HSW skill building. H2014HK currently is out of home non-vocational rehabilitation, per BHDDA Code Chart must be four or more hours per day.	Jessica/ Milliman	<p>An initial review by Milliman of the available HCPCS codes provided one code that may be similar, S5100 (Adult day care services, per 15 minutes).</p> <p>Internal BHDDA discussion was around whether S5100 or a new modifier would be the best approach. Would like to hear pros and cons from the group. Suggest using a different modifier, keeping the H2014 code the same, do not change to S5100. Jackie to share the recommendation with Belinda and Morgan.</p> <p>Question: could we use H2014 with a new modifier instead of H2015 for daytime activities (see page 84 of BHDDA Code Chart)? BHDDA to discuss internally.</p>
