## **Check-In and Introduction**

Group used Zoom Annotations to check-in, and Carrie offered an overview of the Vision & Mission Statements as well as the guiding principles.

## **Discussion: COVID-19**

### **Summary of Successes**

Members reported that difficult to reach clients are now engaging at a higher rate than previously. Telehealth implementation went smoothly. NFP connected with Verizon to get phones for moms, free service for 4 months previously.

### **Summary of Challenges**

Challenges include providing services to parents who do not have internet access, providing functional specialized services via Telehealth, the inability to use grant funds for emergency supplies, shifting home visiting time to help with case tracking.

### **Summary of Long-Term Discussion**

Highlighted concerns about whether Telehealth could provide the same connection as face-to-face meeting, possible continuation of payment for telehealth services in the future, and potential integration of telehealth into standard face-to-face practices.

## **Core Knowledge and Competencies**

Sub-committee presented a finalized version of the crosswalk identifying all areas that home visitors should have common knowledge of and what models require training for those areas.

## Core Guidelines

Approved changes made to definitions previously highlighted within the core guidelines. Version finalized and will be revisited as needed or every two years.
