Terminologies and Definitions

Passive Eligibility:

Individuals who meet the full criteria to be passively enrolled into MI Health Link Program

Enrollment:

Individuals currently enrolled in MI Health Link

Passive Enrollment:

An enrollment process through which an eligible individual is enrolled by the MDHHS (or its vendor) into an ICO, following a minimum 60 calendar day advance notification. Eligible individuals are automatically enrolled if they do not chose to opt out of the program

- PACE and MI Choice participants, people with a union or employer sponsored Medicare retirement plan, and those
 identified as a native American, Alaskan, or migrant are not eligible for passive enrollment
- Effective July 1st 2016, MI Care Team Program participants are not eligible for passive enrollment; however, they will be able to voluntarily enroll in MI Health Link

LOC (Level of Care):

State-specific codes that indicate certain level of healthcare service needs


Voluntary Disenrollment:

Enrollment by Region





Eligible for Passive Enrollment by Region







Enrollment Retention by Month




Enrollment Retention Percentage by Month














ICO Deeming Retention Percentage by Month
