Honoring the Past, Celebrating the Present, and Looking Towards the Future: RICC Summit

On July 12, RICC members from across the state gathered in Lansing to celebrate 43 years of advocacy.

The day began with honoring the past accomplishments of RICCs. Executive Director, Vendella Collins, shared the history of how the Regional Interagency Coordinating Committees (RICCs) were formed in 1973 and were made up of agency staff. Recognizing the need to hear people with developmental disabilities' voice at the table, RICC membership went from heavily agency staffed to the majority of people with developmental disabilities. Now, Regional Inclusive Community Coalitions (RICCs) are spread across the state and are grassroots advocacy groups.

Ontonagon Helps to Build a Park

The Ontonagon RICC is making their community more inclusive. They are planning to turn a plot of land, donated by the Ontonagon Village, into an accessible park. The RICC is currently writing grants and looking for funding. They have already received \$4,000 from Western Upper Peninsula Planning and Development Region to start laying a brick path. The new park will have accessible picnic tables and community areas. The RICC is also looking at creating murals on the walls that would highlight the community and the history of Ontonagon.



MOU Signed to Support Students Transitioning to Employment

On June 21, the DD Council along with Lieutenant Governor Brian Calley, the Michigan Department of Health and Human Services' Behavioral Health and Developmental Disabilities Administration, Michigan Rehabilitation Services, the Workforce Development Agency, the Michigan Department of Licensing and Regulatory Affairs and the Michigan Department of Education met in Flint to sign a Memorandum of Understating (MOU).

This document was created to help increase the number of students with disabilities transitioning from school and post-secondary education to employment. Beyond their agency specific commitments, everyone agreed to joint responsibilities, including:

- Working collaboratively to improve the transition and employment service system
- Identifying and implementing effective transition and employment services
- Pursuing and coordinating resource acquisition
- Promoting and encouraging coordinated transition and employment services at the local and state levels
- Building upon current capacity to provide transition and employment services
- Developing and providing common training and professional development opportunities for transition and employment services personnel
- Sharing responsibility for publication and dissemination
- Giving timely notice to other agency partners of the agreement of proposed rule amendments relating to transition and employment services, along with allowing opportunity to comment on proposed amendments

MOU Signed to Support Students Transitioning to Employment Continued

The MOU was a result of the hard work of the Office of Disability Employment Policy (ODEP) and the interagency employment work group, led by the Council. The interagency team (made up of the departments above) continues systems change work to implement Employment First policies in Michigan.
