#### I. Welcome and introductions

- Chair Edwards-Sutton called the meeting to order at 10:20 am and asked Commissioners to introduce themselves..

- II. Approval of February 17, 2017 Meeting Minutes Chair Edwards-Sutton requested a motion to approve the minutes from the February 17, 2017 MCCAEO meeting. Fran Amos made the motion to approve the minutes; James Borchard seconded the motion. The motion passed unanimously.

## III. State ID Update – Paula Kaiser VanDam

- The State ID Taskforce gave a presentation to the Interagency Council on Homelessness (ICH). The ICH is creating a white paper around this issue.
- There may be some funding to support getting birth certificates
- They are requesting that the Secretary of State add homelessness to the Free ID for Me program
- They are pushing the Secretary of State on policy issues, pilot, alternative documents to become standard practice across all Secretary of State offices.
- Jill asked if Commission can endorse the white paper; Commission can join the alliance with what the asks will be and support those asks.
- Jill, Jessica, Paula and Kris will be meeting with Director Lyon on the issue.
- Legislative visits: What is the ask?
  - o New Jersey just announced free ID/birth certificate for homeless
  - o MCAH –Senator O'Brien is asking to expand Free ID for Me to include veterans; asking her to expand to other populations
  - o Jacob Maas suggested it would be good to share data form Dept. of Corrections on how many released with vital documents vs. without documents

### IV. Integrated Service Delivery – Paula Kaiser VanDam

- Phillip Bergquist presented on Integrated Service Delivery to the Commission a year ago
- There will be a new MI Bridges portal, Universal Case Load, and contact center

- The portal will include:
  - o Needs assessment
  - o Resources (using the 2-1-1 database)
  - o Ability to apply for benefits
  - o Can give consent to have agency staff see specific information on benefits, renewal dates, and correspondence
- Pilot will take place in Muskegon from September to December
- The portal will go live statewide in January
- Universal Case Load and Contact Center will pilot in January and go live in mid-2018

- VI. Financial Empowerment Presentation by Ross Yednock, CEDAM
  - Following Ross' presentation, Commissioners had a discussion around this top area and whether to focus on this for the next Commission Report

  - Funding Update
    - President Trump's budget has eliminated CSBG and Weatherization Assistance Program funding. Continuing resolution has been passed that funds through September.
